- * For reinstatement of Fellowship/Membership, the following subscriptions must also be paid:
- (1) Subscription fee for the year when the Fellow/Member was removed from the register.
 - (2) Subscription fees for the arrears of all outstanding years and the year when the Fellow/Member is rejoining.

- # A Higher Trainee of CDSHK must be a College member as well. If the candidate is both a College member and Higher Trainee, the annual membership fee will be waived.

Notes:

- (1) The annual subscription for **new Fellows** admitted after 1 July will be a half-year subscription.
- (2) Trainees who do not pay their annual trainee subscription could pay in arrears plus 5% surcharge before sitting the examination.
- (3) A letter will be sent to members who have resigned/terminated their Fellowship/Membership to remind that their College qualifications are no longer valid and therefore cannot be claimed in any circumstances.

Surcharge:

Fellows/Members who do not settle their subscription before 30 June of that year: it is the College's policy that all late payments (received after 30 June) will be subjected to a 5% surcharge.

College Fellows will pay their subscriptions directly to the Honorary Treasurer of the College.

The Council reserves the right to terminate one's Fellowship/Membership/Trainee status if one does not settle the required annual subscription more than one year in arrears.

Appendix 1

Training Vetting Fee

The following practices, which are applicable to basic trainee applicants, have been adopted with effect on 20 December 2016.

- a) No vetting fee would be levied up to a period of two years of retrospective recognition of training period. Vetting fees will be levied for the retrospective recognition of the third and the fourth year of training;
- b) All applications for retrospective recognition of basic training are subject to the discretion of the Council;
- c) This policy will be reviewed by the Council from time to time;
- d) Vetting fees for 2017 are shown in the following table:-
