Subsequent to the successful completion of the Membership in General Dentistry (MGD) training programme 2012-2014, The College of Dental Surgeons of Hong Kong (CDSHK) and Hong Kong Dental Association (HKDA) came to an agreement in March 2015 for HKDA to be the administrator of the Membership in General Dentistry (MGD) training programme 2015-2017.

The training programme is mainly designed to prepare the MGD trainees for the MGD Part I and Part II examinations. It is a competence-based programme according to the guidelines of accreditation and training in MGD. For further details of the training programme, please refer to CDSHK's website ([www.cdshk.org](http://www.cdshk.org)).

The training programme is module-based, consisting of CGD (Committee of General Dentistry) accredited lectures and workshops on clinical practice and essentials of dental practice on General Dentistry. There are some supporting programmes to guide trainees in examination preparation and they can be useful to interested practitioners.

## Dental Materials Science

Module Code: CP11

### Speaker: Professor Michael BURROW

Professor Michael Burrow graduated from the University of Adelaide with BDS in 1981, MDS in Prosthodontics in 1987. He completed his PhD at Tokyo Medical and Dental University in 1994. In 2003 was awarded a Master of Education from the University of Melbourne and MRACDS (Pros) and FRACDS in 2010. In 2014 he received a Doctor of Dental Science degree from the University of Adelaide.

Before going to Hong Kong in 2010 he was a Professor in Restorative Dentistry and Clinical Dean at the Melbourne Dental School where he returned to the research post of Professor and Chair of Biomaterials in mid-2014. Whilst at the Faculty of Dentistry of the University of Hong Kong he held the position of Clinical Associate Professor in Oral Diagnosis & Polyclinics and Undergraduate Program Director in Operative Dentistry and is currently an Honorary Professor in Dental Materials.

He is an examiner for the final Fellowship (GDP) examinations of the Royal Australasian College of Dental Surgeons, is currently on the Editorial Boards of five international journals and published over 190 refereed papers and referees papers for approximately 30 journals. He has lectured in Australia and Internationally.

He has received competitive grants from the NHMRC, ADRF, GRF of Hong Kong, as well as industry-supported grants. His research background is adhesion of resin-based adhesives and glass ionomer cements to tooth substrates, clinical evaluation of adhesives and long-term adhesion of adhesives and dental education.

Synopsis : Dental practice involves the use of dental materials for almost every aspect of treatment. Each year manufacturers introduce new or updated materials all of which are usually claimed to be superior or make treatment easier. However, most practitioners do not always understand the relevance of the information provided by the manufacturer or the limitations of the information as it relates to clinical practice. Many of the physical properties do not correlate well to, for example, restoration survival. What do tests such as fracture toughness or polymerization shrinkage stress actually mean with respect to clinical use?

The presentation will recap some of the basic concepts and tests that are related to the evaluation and performance of dental materials. The talk will focus more on restorative materials, as it is this group of materials most general practitioners use daily. Many practitioners have concerns about the longevity of adhesively bonded restorations. Resin composites are still regarded as having a poorer survival rate compared with amalgam. The current evidence will be explored from the aspect of the performance of recently introduced restorative materials, namely the Bulk fill composites – do they really work, are they better? From the aspect of adhesives, are the Universal adhesives a great improvement on what we already have?

## Rehabilitative Therapy

- Synopsis : As the population ages and patients maintain their teeth for longer, the chances of partial tooth loss that results in an aesthetic or functional problem will tend to increase.

Currently there are numerous options for the replacement of missing teeth. This is often dictated by patient circumstances or financial decisions. The responsibility of the general practitioner is to determine which treatment options may best serve their patient's needs. Therefore the process of planning the treatment is often the difficult part of care provision.

The lectures will discuss the points important to the planning for replacement of missing teeth. What are the options and what might be the advantages or disadvantages of the options.

The basic concepts of tooth preparation and bridge design and how this may vary with respect to the variety of material options will also be discussed. The clinical evidence for survival of various forms of prosthesis will be introduced.

The final portion of the presentation will consider the various aspects of design for success for removable prostheses. How to obtain the best outcomes when abutment teeth may need crowns and how this can be incorporated into the overall prosthesis design.

## Aesthetic Therapy

- Synopsis : As social media has exposed us to a fast paced world of ever changing information, patients are more aware of their treatment options and often wish to 'look better' based on their perception of how the media is portraying so-called 'aesthetic perfection'.

This talk will briefly outline various aspects of aesthetics in respect of what can be done as part of an oral health care plan. What are the options available from the aspect of treatment alternatives and what materials can be used?

The simplest change is through bleaching – the current evidence for this method will be outlined and how best to obtain good outcomes as well as prevent some of the problems patients face during treatment.

The next level of providing an aesthetic enhancement for patients is through the use of veneers, either resin composite or ceramic. The differences using either of these materials will be introduced and how to obtain a pragmatic but good patient outcome will be discussed. How do the two material types compare from the aspect of strength and longevity?

How best to cement ceramic materials to the tooth surface? Repair of ceramic will be briefly outlined.

## Law and General Dental Practice

Dr Edward Fan is a dental surgeon and a barrister-at-law. He obtained his BDS from Guy's Hospital Medical School, University of London in 1976. He has worked in several hospitals in the UK and in private practices both in the UK and Hong Kong. He was a part-time lecturer at Faculty of Dentistry, University of Hong Kong (1983 to 1987), and at King's College Hospital Dental School in London (1996 to 1998). He held the appointments of part-time dento-legal adviser at DPL, London in 1998, DGDP (UK) RCS Eng examiner (1993 to 1996), and MGDSRCS (Edin) examiner (1995 to 1998). He is the first MDGS RCS Edin holder in Hong Kong. He is also the holder of Diploma in Forensic Odontology and Diploma in Legal Aspects of Medical Practice.

He was called to the English Bar and the Hong Kong Bar in 1997. He has been a member of the Chartered Institute of Arbitrators, UK since 1999 and a Mediator since 2010.

Dr Fan is currently a practising Barrister-at-law in Hong Kong. His areas of practice include personal injury, medical negligence as well as criminal cases. He has been an Honorary Associate Professor at the Faculty of Dentistry, HKU since 2013 and a part-time Lecturer at the Faculty of Law, HKU since 2014. He is one of the Legal Advisers to the Adjudicating Officer in Police Disciplinary Proceedings and a Member of the Panel of the Board of Review (Inland Revenue Ordinance).

Synopsis : A general dental practitioner ("GDP") is not only a clinician, he is also a party to contracts with his patients, his employees or his employer, his landlord(s), etc. He may also be an occupier of the clinic and the owner of the equipment therein, some of which he is also the licence holder. In some cases, he may also assume the role of a bookkeeper/account in dealing with tax matters. Accordingly, a GDP has numerous liabilities, which may be classified under three main categories, namely, professional, civil and criminal. An MGD holder, in addition to the possession of up-to-date clinical knowledge, should also be familiar with his liabilities in general dental practice. Professional liability of a GDP will be presented in this seminar. Areas intended to be covered in this seminar include risk management, informed consent, complaint handling, matters related to Dental Council and court proceedings. Since an MGD holder is poised to become a specialist in Family Dentistry in due course, the role of an expert witness will also be discussed.

Dr Haston Liu graduated with the Bachelor of Dental Surgery (BDS) from the University of Hong Kong (HKU) in 1988. He also obtained the Postgraduate Diploma in Dental Surgery (PDipDS) from HKU and the Diploma in General Dental Practice (DGDP) from the Royal College of Surgeons of England in 1996. He acquired the Membership in General Dental Surgery (MGDS) from the Royal College of Surgeons (RCS) of Edinburgh in 1997. He was further awarded the Fellowship of the Hong Kong Academy of Medicine (FHKAM) in Dental Surgery and the Fellowship of the College of Dental Surgeons of Hong Kong (FCDSHK) in the specialty of Family Dentistry in 2003.

Apart from practicing in the private sector for more than 20 years, Dr Liu has been working as a part-time lecturer of the Faculty of Dentistry of HKU from 1990 to 2010. He held the position of Examiner of the examinations of Licensing Exam, MGDS and MGD. He is a member of the Specialty Board of Family Dentistry.
