# President's Report

It is a fruitful year as the College is privileged to enjoy its 30<sup>th</sup> Anniversary of establishment following the past three years of struggles and lockdown in pandemic. It is truly the demonstration of the power of unity and dedication of all the College members, Committees, Subcommittees, Specialty Boards and Council to maintain our training and development without interruption.

This year, we are delighted to have three newly elected Council members, Dr Chu Kit Ling Justine, Dr Fong Kin Man and Dr Ho King Lun while Dr Fang Tak Sang Daniel and Dr She Tsang Tsang have been re-elected to the Council. Dr Chu Kit Ling Justine succeeds Dr So Cheuk Hang as the Chairperson of the Dental Young Fellows Chapter. Together with the committee members, they continue to engage with our young Fellows and adding new momentum and insight for the development of the College.

Education and specialists training remain as the core business of the College and I shall express my heartfelt gratitude to Prof. Leung Wai Keung for his extraordinary leadership to Education & Examinations Committee. Together with the Chairpersons, members, supervisors, trainers and examiners of 8 Specialty Boards, we are able to provide a comprehensive training for more than 110 Basic and Higher Trainees among 26 training centres currently and mounting our own Specialties Intermediate and Exit Examinations compliant to international standards.

In view of the evolving professional practices in fulfilling the society demands and complexity of treatment needs, it is necessary for College to evolve and adapt to the ever changing educational environment. The Hong Kong Academy of Medicine, together with its 15 constituent Colleges has published the “Position Paper on Postgraduate Medical Education 2023” which served as a blueprint for the reform and advancement in training and education to our future specialists. I shall acknowledge the tremendous effort of various Specialty Boards and their members who engage in the review and refurbishment of their Specialty training curricula towards a competency-based approach to ensure the provision of contemporary and high standard of patient care by our members. Drs Ho King Lun and She Tsang Tsang were nominated as representative of CDSHK in the HKAM Faculty Development Working group organized by the Hong Kong Jockey Club Innovative Learning Centre for Medicine (HKJC ILC) to discuss the development of the curriculum and its ongoing review, faculty development and the requirements of trainers and examiners, standard maintenance and quality assurance of training and assessment.

The Membership of General Dentistry MGD 2021-2023 Diet is concluded successfully following the Final Examination held in August and we should express our sincere appreciation to Dr Yiu Bun Ka, Chairperson, Members of the Committee of General Dentistry (CGD), speakers of training modules, mentors, Dr Ng Chi Hong, Chief Examiner and colleagues in the Examination Panel. Dr Yiu is re-appointed by the Council as the

Chairman of CGD. Together with his team of CGD members, a new diet of MGD training is expecting to commence in 2024.

New CME/CPD circle 2023-2025 is commenced. The guidelines has been updated with introduction of new CME activities that may facilitate members in extending their learning opportunities. Great thanks to Dr Ho Fu Tak for leading the CME Subcommittee and their continuous effort in vetting and accreditation of CME/CPD activities.

The Tricollegiate Scientific Conference is conducted successfully on 8-9 July in which this long tradition of collaboration between Royal Australasian College of Dental Surgeons, College of Dental Surgeons, Singapore and College of Dental Surgeons of Hong Kong is resumed after the pandemic. Together with two of the first ever pre-conference workshops, this event provided a vibrant platform for over 300 local participants for knowledge exchange and foster relationship. The conference is also live streamed to members of RACDS and CDSS overseas. I would like to thank Dr So Cheuk Hang for his distinct leadership and the relentless support of the members of Scientific Meeting Committee in making up such as remarkable education event. Furthermore, the Memorandum of Understanding with the Royal Australasian College of Dental Surgeons is renewed in July and we witness the seamless collaboration between the two Colleges in conducting the Conjoint Membership RACDS/CDSHK Examinations for the coming diets.

The College is invited to express our views in a written submission to the Health Bureau and the Government on the “Proposed Legislative Amendments to the Dentists Registration Ordinance (DRO)”. A follow up meeting with the representatives of Health Bureau and Dental Services, Department of Health is conducted recently and we are able to discuss on the future arrangement of Specialists training to ensure the delivery of highest standard of specialist care in Hong Kong. It is also reiterated in the submission of views for the “Policy Address 2023” that the Government should increase support and resources for the training of local specialists and dentists as a long-term goal since it is the most fundamental and effective means to ensure a steady supply of high quality dentists for local needs. We look forward to maintaining an ongoing dialogue with the Health Bureau regarding the development and Government’s support on local specialists training. The College is ready and committed to offering its expertise in postgraduate training and to safeguarding the standards for patient care. We are glad to work closely with various stakeholders in the “Working group on oral health and dental care” initiated by the Health Bureau. The working group will advise the Government on the priority areas for enhancements to oral health measures and dental care services, including the level of essential primary dental care services at different life stages and the scope of publicly-provided or funded dental care services. More details will be released in 2024.

There is a series of events organised for the 30<sup>th</sup> Anniversary of CDSHK which engaged hundreds of College members in celebrating this important milestone of our College. I shall thank Dr Fang Tak Sang Daniel, Chairperson of the 30<sup>th</sup> Anniversary Organising Committee and his team members, Drs Ho Fu Tak, Ho King Lun, She Tsang Tsang, So Cheuk Hang and Wan Kong Yuk Annie for their enormous effort and dedication in organising these celebrations successfully. Through this occasion, we are deeply grateful for the dedication,

effort and foresight of our senior Fellows and members in pursuit of excellence in College's development in last three decades. I must express my sincere thanks to Dr Fang Tak Sang Daniel, Honorary Secretary, members of House Committee, Ms Iris Yeung, Senior Executive Officer and the Secretariat staff for their effort and administration support that you could hardly imagine in order to keep the College running on the right tract efficiently.

Lastly, it is my greatest privilege to work with a group of dedicated and elite Councillors and College members before I finish my twelve years of consecutive services in the Council. It is the time for me to step down but to serve the College continuously in other ways. I am confident that the new Council will continue its mission to uplift the College to next level in coming decades.

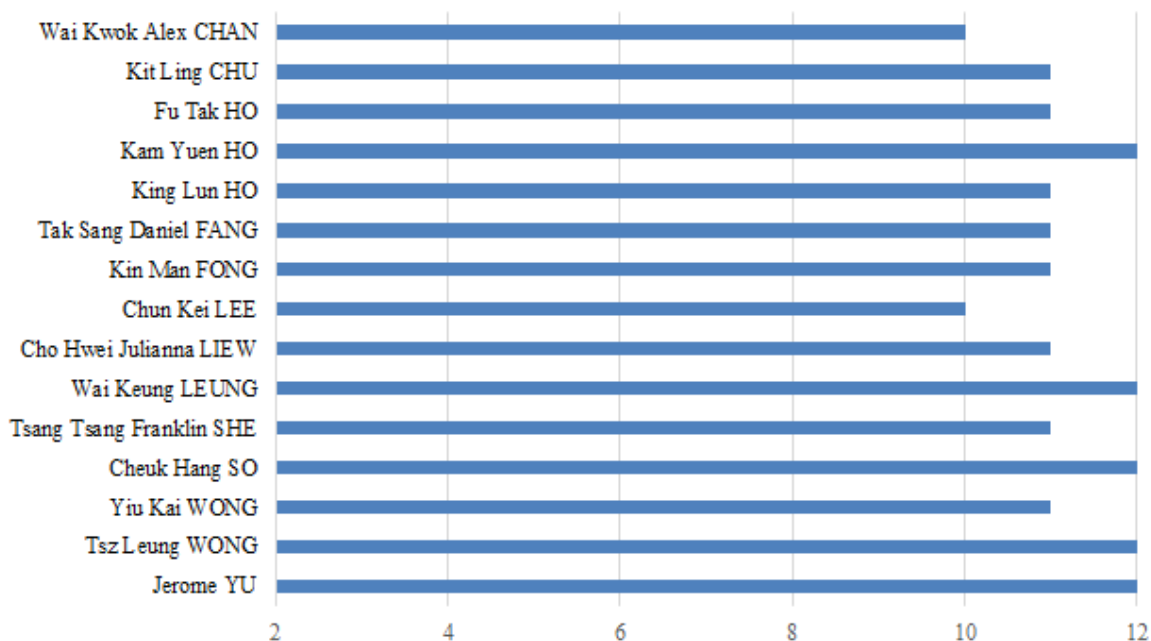

# Continuing Medical Education Sub-committee

## 1. Introduction

It is the objective of the Hong Kong Academy of Medicine to promote the advancement of the art and science of medicine, foster the development of postgraduate medical education and continuing medical education as well as promoting the improvement of health care for Hong Kong citizens. The purpose of Continuing Medical Education and Continuous Professional Development (CME/CPD) is to meet these objectives. In the pursuit of lifelong learning with a view to protect our own patients, CME is now required not only from Fellows, but also from our members and trainees as well.

The CME Sub-committee follows the policy that accredited CME activities should be educational with an objective to enhance our competence and improve outcome of patient care. Such CME activities must be based upon the best scientific evidence available and free from any undue or biased commercial influence.

2023 is the first year of the 3-year cycle of CME/CPD between 1 January 2023 and 31 December 2025. An updated version of the College's Principles and Guidelines on CME and CPD for the next cycle (2023-2025) is available at the College's website.

Any changes in the administration of CME activities are regularly communicated by emails and reported in the College's Newsletter.

**7. All Fellows, Non-FHKAM Specialists, MGD Holders and Higher Trainees should take every effort to submit their unclaimed CME/CPD activities to the Secretariat within two weeks after the CME/CPD activities, to ensure their inclusion in the cycle.**

**8. Applications for accreditation of CME/CPD activities for the first 8 months in 2023 of the current CME/CPD cycle:**

Between 1 January 2023 and 31 August 2023, the CME Subcommittee has vetted, approved, and accredited a total of 481 (439 approved / 42 rejected) scientific meetings or training courses held locally and overseas.

**9. Other activities and Future development**

Facing the increasing demand, the means of CME application needs to be more convenient, efficient, and accurate. Consequently, an online program, e-CME application is being developed. Through the program, applicants can submit their application and view their application status. In addition, CME calendar will be included so that fellows and general dentists can view the upcoming dental and medical CME events.

Besides, two new CME activities is going to be added, course creators for eHKAM LMS will receive the same non-passive CME credit as speaker. In addition, speaker for the paramedical personnel is also added. Please refer to update guideline for specifics.

### 2022 Winter Scientific Meeting

DENTISTRY AND MEDICINE – INTER- AND INTRA-DISCIPLINARY NETWORKING  
PART 3: ONCOLOGY AND RECONSTRUCTION  
6 NOVEMBER 2022

This is the finale and Part 3 of the ‘Dentistry and Medicine – Inter and intra-Disciplinary Networking’ series with the theme of Oncology and Reconstruction. We had 308 online and 66 physical attendees at the Pao Yuk Kong Auditorium. Our President, Dr Katherine Leung kicked off the event and welcomed our audience. The morning session was chaired by Dr Gary So and Dr Amelia Cheung. We were privileged to have the following speakers: Dr Fung Siu Chung, Michael Chao and Crystal Ng from the Department of Dentistry and OMFS, the United Christian Hospital, highlighting the dental role in managing oral cancer. Dr Polly Fung, a private practitioner, introduced the oral medicine approach in managing oral potentially malignant disorders. Next, we had Dr Jeren Lim from the division of Head and Neck Surgery of the Department of Surgery, the United Christian Hospital, discuss the surgical aspect of oral cancer. The morning session was completed by Dr Kwan Chung Kong, Department of Oncology, the United Christian Hospital, who gave us an update on the non-surgical treatment of oral cancer.

The afternoon session was chaired by Dr Jason Wong and Dr Jerome Yu. Dr Au Ka Li and Dr Yau Kar Yin from the Department of Dentistry and OMFS, the United Christian Hospital, presented the OMS aspect, complication management and the role for pre-prosthetic and craniofacial prosthesis. Dr Patrick Wu, a specialist in Prosthodontics, introduced to us the dental and maxillofacial prosthetic reconstruction in resected tumour defects. Prof. Richard Su from OMFS, Faculty of Dentistry, HKU, concluded the program by sharing with us the experiences of his team in using new technologies for oral cancer diagnosis and treatment.

I would like to thank our speakers, moderators, members of the CDSHK Scientific Meetings Committee and the Council, Secretariats and the HKAM technical team for their collaborative efforts to make this webinar/physical meeting run smoothly. ### **2023 Tri-collegiate Scientific Conference**

#### **EVOLUTIONS OF DENTISTRY THROUGH THE AGES**

8 July to 9 July 2023

Instead of having 2 scientific meetings as before, this year we organized a two-day tri-collegiate scientific conference with both the hands-on workshops and lectures in July. The conference was jointly collaborated by 3 reputable Dental Colleges worldwide, The College of Dental Surgeons of Hong Kong (CDSHK), Royal Australasian College of Dental Surgeons (RACDS), and College of Dental Surgeons Singapore (CDSS).

It marked a significant milestone as the first physical international event held by CDSHK since the COVID-19 lockdown in Hong Kong. The resumption of physical events after a prolonged period of restrictions due to the pandemic was a momentous occasion for the dental community in Hong Kong and beyond. It signified a return to a sense of normalcy and the opportunity for professionals to come together, exchange knowledge, and engage in meaningful discussions face-to-face.

The conference also coincided with the 30th anniversary of CDSHK, adding an extra layer of significance and celebration to the occasion. Its alignment with the 30<sup>th</sup> anniversary of CDSHK added a sense of pride and reflection for the College. Over the past three decades, CDSHK has played a pivotal role in promoting excellence in dental specialist practice, education, and training. The conference served as a testament to the organization's commitment to advancing the field of dental surgery and its dedication to supporting the professional growth of its members.

The theme of the conference this year was “Evolutions of Dentistry Through The Ages”. It brought together dental professionals, researchers, and experts worldwide. We were delighted to have over 350 local and overseas delegates participated in person, while members from RACDS and CDSS who were unable to join physically can participate via Zoom.

This conference featured a diverse range of workshops and lectures delivered by renowned speakers from various dental specialties. We had a total of five speakers for the workshops and nine speakers for the lectures. The event was graced by the presence of three esteemed Guests of Honor: Dr Simon Ho, President, CDSHK; Dr Susan Wise, President, RACDS; Dr Yu Jin Poh, President, CDSS.

The conference commenced on 8<sup>th</sup> July with two parallel workshops held in the morning. The first workshop focused on "Technical Tips and Tricks of Surgical Wound Closure and Care" and featured speakers Dr Sit Ka Fai, Dr Law Yee Hung, and Dr So Cheuk Hang. They



are all Specialist in Oral and Maxillofacial Surgery served in various trauma centres before. The workshop focused on the importance of proper wound care and wound approximation in surgical procedures across different dental specialties with hands-on practice.

The second workshop addressed "Oral Appliance - Obstructive Sleep Apnea (OSA)" and featured speakers Dr Wan Kong Yuk Annie and Dr Lam Yu Hang. Both Dr Wan and Dr Lam are Specialist in Prosthodontics with valuable experiences in managing patients with OSA. Participants had the opportunity to learn about the rationale behind the oral appliance therapy (OAT) and to enhance their chairside skills in its fabrication.

The first lecture session began on 8 July afternoon after the kick-off opening addresses by the three distinguished guests of honor: Dr Simon Ho, Dr Susan Wise and Dr YuJin Poh. This session covered topics in periodontology, OMS and endodontics, moderated by Dr Au Ka Li and Dr Ho Fu Tak.

Dr Wong Li Beng, Specialist in periodontology in Singapore, presented on "Managing Periodontal Disease: Moving from Outcome-driven to Patient-centric Approach." Dr Wong discussed the shift towards a patient-centric approach in the management of periodontal disease. He emphasized the importance of patient-reported outcome measures and highlighted changes in treatment philosophy.

Prof. Gary Cheung Shun Pan, Specialist in Endodontics, discussed the "Management of the Hopeless Teeth in the Digital Age." Prof Cheung addressed the challenges of determining the prognosis and restorability of badly broken down teeth. He also shared his experiences on various treatment options, including root canal treatment, extracoronary restoration, autotransplantation, root resection, and hemisection.

Dr Lau Sze Lok, Specialist in Oral Maxillofacial Surgery presented on "OMW or OMG in OMS... Where Are We Now?" Dr Lau focused on the rapid changes and advancements in dentistry, medicine, and oral and maxillofacial surgery (OMS). He discussed technologies such as 3D printing, virtual reality, augmented reality, artificial intelligence, and robotic surgeries, and emphasized the need for practitioners to embrace these advancements.

On 9<sup>th</sup> July morning, three lectures highlighting restorative dentistry, OMS and periodontology were conducted. Dr Melissa Fok and Dr Leung Tsz Man served as moderators for this session.

Prof. Michael Burrow, discussed "Navigating Strategies for the Management of Root Caries." Prof Burrow addressed the management of root caries, a problem that has emerged due to people retaining their teeth for longer. He explored different strategies ranging from non-restorative interventions to restorations, with a focus on the selection of appropriate treatment based on individual circumstances.

Dr Raymond CW Wong, Specialist in Oral and Maxillofacial Surgery in Singapore, presented on "The 4th Industrial Revolution in Dentistry: Applications in Oral and

Maxillofacial Surgery." Dr Wong brought out significant milestones in dentistry over the past few decades, particularly in the field of oral and maxillofacial surgery. The presentation covered advances in 3D printing, augmented reality, new materials, gene expression testing, and digital health records.

Dr Ho King Lun, Specialist in Periodontology, addressed "Advances in Periodontal Therapy: A Paradigm Shift from Resective to Regenerative Approach." Dr Ho explored the shift in periodontal therapy from resective approaches to regenerative techniques. He discussed the potential of regenerative therapy in restoring lost periodontal support and improving clinical outcomes.

The afternoon session of 9th July consisted of three lectures moderated by Dr Sylvia Ng and Dr Fong Kin Man, with focus on Prosthodontics, OMS and orthodontics.

Prof. Cynthia Yiu, Specialist in Paediatric Dentistry, enlightened the audience on "Paediatric Dentistry - The Past, Present, and Future." Prof Yiu provided an overview of the evolution of paediatric dentistry, including emerging oral conditions, changing treatment philosophies, dental materials, and technology. She also highlighted the restoration of oral health, function, and aesthetics for children as a focus of future directions in the field.

Dr Lam Yu Hang, Specialist in Prosthodontics, spoke about the "Current Progress of the Use of Artificial Intelligence in Restorative Dentistry. Dr Lam focused on tooth replacement and gum disease detection. He highlighted the application of AI in designing biomimetic dental prostheses by learning from the features of a patient's remaining teeth. Additionally, the use of AI in detecting gum inflammation based on intraoral photographs captured by smartphones was discussed as a potential screening tool for early gum disease diagnosis.

Dr Wilson Lee, Specialist in Orthodontics, presented on "Face-driven Orthodontics - How Are Invisible Orthodontic Appliances Affected by This Concept?" Dr Lee covered the significant changes that have occurred in the past 30 years in orthodontics, from the traditional metal braces to the invisible orthodontic appliances. He critically reviewed the indications and limitations of the latest removable clear aligners and lingual fixed appliances based on recent literature and clinical expertise.

Overall, the Tri-collegiate Scientific Conference was a successful and significant event that fostered collaboration and knowledge sharing among dental professionals from different regions. The conference provided a platform for participants to learn about the latest advancements in dentistry, exchange ideas, and strengthen professional networks.

The contributions of different parties contributed to the success of the conference, making it a memorable and impactful experience for all involved. It is a moment of great joy and pride as we reflect upon the collective effort and dedication that made this event possible.

The IT Committee continued to provide secure and reliable services to the College this year.

After reviewing the computers and software for use in our College Secretariat and examinations, we provided an additional monitor for all College Secretariat colleagues, procured new software and 5 new notebook computers to increase office efficiency, replaced the old computers to maintain IT security, and reduced recurrent expenses by discontinuing the renting of notebook computers from the HKAM for examinations.

The existing iCME/CPD Program will be further enhanced to send email alerts to Members and Fellows who have not yet met the CME requirement at an earlier stage, allowing them sufficient time to fulfill their requirements before the end of the CME and CPD cycle.

To increase efficiency and effectiveness in handling the application for CME/CPD accreditation and recording CME/CPD points obtained by Fellows, Members, and Higher Trainees, the IT Committee and Ms Serina SO, our Executive Officer responsible for CME/CPD matters, held a meeting on 19 July 2023 with iFour Limited to explore the feasibility of developing a new system to automate these labor-intensive processes as much as possible.

A demonstration session was held on 18 September 2023 to invite iFour Limited to present the functionality of the HKAM e-Portfolio system, which is currently being used by some of the constituent Colleges with or without modifications. Specialty Board Chairs and their representatives, members of the Council and IT Committee joined the session. The HKAM e-Portfolio system will be evaluated to determine whether it can be adapted to suit the needs of the specialists training in our College.

## **NOTES ON THE FINANCIAL STATEMENTS**

### **1. GENERAL INFORMATION**

The College of Dental Surgeons of Hong Kong (“the college”) was incorporated in Hong Kong on 23 February 1993 as a company limited by guarantee. Every member of the college undertakes to contribute, if required, an amount not exceeding HK\$100 to the assets of the college in the event of its being wound up.

The address of the registered office of the college is Room 902, HKAM Jockey Club Building, 99 Wong Chuk Hang Road, Aberdeen, Hong Kong.

The college is engaged in promoting for the public benefit the advancement of knowledge in the field of dental surgery and its associated subjects and promoting training and research in dental surgery.

The financial statements are presented in Hong Kong dollars which is the same as the functional currency of the college.

### **2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES**

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the periods presented, unless otherwise stated.

#### **a) Basis of preparation:**

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standard for Private Entities (“HKFRS for Private Entities”) issued by the Hong Kong Institute of Certified Public Accountants (“HKICPA”) and the Hong Kong Companies Ordinance. These financial statements have been prepared under historical cost convention.

The preparation of financial statements in conformity with HKFRS for Private Entities requires management to make judgments, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenditure. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgments about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

## NOTES ON THE FINANCIAL STATEMENTS

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)

#### b) Property, plant and equipment:

Property, plant and equipment, other than construction in progress are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after the property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of comprehensive income in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of the property, plant and equipment, the expenditure is capitalised as an additional cost of that asset.

Depreciation on property, plant and equipment is calculated by the straight-line method to allocate cost to their residual value over their estimated useful lives as follows:

College gowns	20% per annum
Leasehold improvement	20% per annum
Furniture and fixtures	20% per annum
Office equipment	20% per annum

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

An item of property, plant and equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. The gain or loss arising on derecognition of the asset (calculated as the difference between the net sale proceeds and the carrying amount of the asset is included in the statement of comprehensive income in the year in which the item is derecognized).

#### c) Inventories:

Inventories are stated at the lower of cost and net realizable value. Cost is calculated by using the weighted average method. Net realizable value is determined by management based on prevailing market conditions.

#### d) Impairment:

At the end of each reporting period, the college reviews internal and external sources of information to determine whether the carrying amounts of its tangible assets have suffered an impairment loss or impairment loss previously recognised no longer exists or may be reduced. If any such indication exists, the recoverable amount of the asset is estimated, based on the higher on its net selling price and value in use.

If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. Impairment losses are recognised as an expenditure immediately.

### 2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)

d) Impairment: (cont'd)

A reversal of impairment losses is limited to the carrying amount of the asset that would have been determined had no impairment loss been recognised in prior years. Reversal of impairment losses is recognised as income immediately.

Impairment loss on financial assets which is carried at amortised cost is measured as the difference between the asset's carrying amount the present value of estimated future cash flows discounted at the financial asset's original effective interest rate.

e) Revenue recognition:

Income from subscription and entrance fees is recognised on an accruals basis.

Income from meeting, course and examination is recognised upon completion of services provided.

Interest income is recognised as it accrues using effective interest method.

f) Related parties:

a) A person, or a close member of that person's family, is related to the college if that person:

- i) has control or joint control over the college;
- ii) has significant influence over the college; or
- iii) is a member of the key management personnel of the college or the college's parent.

b) An entity is related to the college if any of the following conditions applies:

- i) The entity and the college are members of the same group.
- ii) One entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).
- iii) Both entities are joint ventures of the same third party.
- iv) One entity is a joint venture of a third entity and the other entity is an associate of the third entity.
- v) The entity is a post-employment benefit plan for the benefit of employees of either the college or an entity related to the college.

b) An entity is related to the college if any of the following conditions applies: (cont'd)

vi) The entity is controlled or jointly controlled by a person identified in (a).

vii) A person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity).

viii) The entity, or any member of a group of which it is a part, provides key management personnel services to the group or to the group's parent.

Close members of the family of a person are those family members who may be expected to influence, or be influenced by, that person in their dealings with the entity.

g) Cash and cash equivalents:

For the purpose of the statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the college's cash management.

h) Retirement benefit costs:

The college joins a defined contribution retirement scheme under the Mandatory Provident Fund Schemes Ordinance (the "MPF Scheme") for those employees of the college.

The college's contributions to the MPF Scheme are made based on a percentage of the eligible employees' relevant income as defined in the Mandatory Provident Fund Schemes Ordinance. These contributions are expensed as incurred. The assets of the scheme are held separately from those of the college in independently administered funds.

i) Government grants:

Government grants are recognised in the statement of financial position initially when there is reasonable assurance that they will be received and that the college will comply with the conditions attaching to them. Grants that compensate the college for expenses incurred are recognised as revenue in the statement of comprehensive income on a systematic basis in the same periods in which the expenses are incurred. Grants that compensate the college for the cost of an asset are deducted in arriving at the carrying amount of the asset and consequently are recognized in the statement of comprehensive income over the useful life of the asset.
