President's Report

This year, we welcomed two new Council members Dr Jerome YU, and Dr Alex CHAN Wai Kwok who re-joined the Council, and two current Council members Dr Tom Fu Tak HO and Professor Wai Keung LEUNG who were re-elected. They will serve on the Council for three years. We also bid farewell to Dr May Wai Mei HO and Dr Yolanda Yee Hung LAW who have served on the Council for nine and three years respectively. On behalf of the College, I would like to express our heartfelt thanks for their valuable contributions to the College in the past years.

Two higher trainees in the Specialties of Oral and Maxillofacial Surgery and Periodontology have successfully completed their training and passed the exit examinations, and will be conferred Fellowships of the CDSHK and the HKAM. Eleven basic trainees in the Specialties of Family Dentistry, Oral and Maxillofacial Surgery, Paediatric Dentistry, Periodontology, and Prosthodontics have successfully completed their basic training, passed the intermediate examinations and can be promoted to higher training. In this connection, I would like to congratulate them for their hard work, and to their trainers, training centre supervisors and their Specialty Boards who have put together tremendous effort and devoted considerable time to the training activities.

Under the astute leadership of Dr Simon Kam Yuen HO, Vice-President (Education and Examinations), amidst COVID-19, Intermediate and Exit examinations were mounted in the 8 specialties, by the respective Specialty Boards, with one joint-board Intermediate examination among the Specialties of Endodontics, Periodontology and Prosthodontics, the Restorative Dentistry Intermediate examination. Candidates and local examiners were physically present while the overseas external examiners took part online. The Standard of our examinations was regarded as comparable to the international fellowship examinations of overseas Colleges. I am indebted to all members of the examination teams including the chief examiners, examiners and question setters for their hard work to uphold the standard of the examinations.

This year is the last year of the 3-year CME/CPD cycle. Under the exemplary leadership of Prof. Wai Keung LEUNG, Vice-President (General affairs and CME), the CME subcommittee has worked industriously throughout the year to vet and accredit numerous activities that attracted CME/CPD points, as well as to liaise with different parties on CME/CPD matters. The subcommittee was also tasked to revamp the CME/CPD guidelines that will be implemented in the coming cycle 2023-2025.

Two scientific meetings were organised in 2022 by the Scientific Meetings Committee. The topics of both meetings stemmed from the interesting themes of the Winter Scientific meeting in 2021. Speakers were invited from various disciplines who shared their expert knowledge and experience with us. To mitigate the risk of COVID-19, these meetings were held online with limited seats to accommodate participants who preferred to attend them physically. Hundreds of fellows, members, trainees, dentists and members of the allied healthcare sectors were attracted to these biannual events.

The current diet of training for the Membership in General Dentistry commenced last year. In this diet, a few selected lectures were open to all dentists and undergraduate dental students and the response was very encouraging.

Last but not least, I am grateful to all the Council members, Chairpersons and members of the various Specialty Boards and College committees for their altruistic contributions. I must also give a round of applause to our Secretarial staff who has rendered unfailing support to the College without which the College business cannot be run in such an effective and efficient manner.

Continuing Medical Education Sub-committee

1. Introduction

It is the objective of the Hong Kong Academy of Medicine to promote the advancement of the art and science of medicine, foster the development of postgraduate medical education and continuing medical education as well as promoting the improvement of health care for Hong Kong citizens. The purpose of Continuing Medical Education and Continuous Professional Development (CME/CPD) is to meet these objectives. In the pursuit of lifelong learning with a view to protect our own patients, CME is now required not only from Fellows, but also from our members and trainees as well.

The CME Sub-committee follows the policy that accredited CME activities should be educational with an objective to enhance our competence and improve outcome of patient care. Such CME activities must be based upon the best scientific evidence available and free from any undue or biased commercial influence.

2022 is the last year of the 3-year cycle of CME/CPD between 1 January 2020 and 31 December 2022. An updated version of the College's Principles and Guidelines on CME and CPD for the next cycle (2023-2025) is available at the College's website.

Any changes in the administration of CME activities are regularly communicated by emails and reported in the College's Newsletter.

Winter Scientific Meeting 7 November 2021

This is the second time the dental college has held the scientific meeting in ‘dual mode’. We had 376 attendants enjoying the lectures at home through online video conferencing and 129 physical attendants at the Pao Yuk Kong Auditorium under the stringent precautionary measures.

The theme of the meeting was ‘Dentistry and Medicine – Inter and intra-Disciplinary Networking’. In the morning, the session was about the management of cleft lip and palate and craniofacial syndrome. It was our privilege to have speakers from the Kowloon East cluster and the Hong Kong Children Hospital of the Hospital Authority discussing about their team’s approach: Dr. Nicholas Chao, Paula Tang and Peter Ku were the medical discipline. Miss Yoyo was a speech Therapist. Dr. Fung Siu Chung, Ho Lai In, Dr. Ricky Wong, Dr. Au Ka Li and Dr. Alvin Kung Yue Hin were the members of the dental team. Furthermore, it was the first time our scientific meetings had the higher trainees speaking with their senior colleagues. Dr. Jessica Yau Ka Yin and Dr. Karen Cheung Ka Yan have certainly done a good job under the guidance of Dr. Au and Dr. Kung respectively. The eye-opening lectures were chaired by Dr. Gary So and Dr. Mildred Wong.

In the afternoon, the focus was on periodontal medicine. Again, we were honoured to have speakers from both the medical and dental fields. Prof. Jin Lijian and Prof. Leung Wai Keung spoke together about the global and local aspects of the development of periodontal medicine. Dr. Tse Sut Yee, who was trained as a dentist and a family medicine specialist, spoke about her perspective on dental and medical collaboration on total patient care. Dr. Norman Chan, who was an endocrinologist and Dr. Anita Wong, a periodontist shared with us their practice model in private practice which strived for the synergistic effect for patient benefits in managing diabetes. This fruitful afternoon session was chaired by Dr. Wan Chi Pui, Dr. Ruby Wong and Dr. Stanley Lai.

Spring Scientific Meeting 22 May 2022

As we have received a lot of positive feedback about the ‘Dentistry and Medicine – Inter and intra-Disciplinary Networking’ of the winter scientific meeting 2021, the dental college held the part 2 with the theme of Sleep Disordered Breathing (SDB). This time, we had 367 online and 71 physical attendants at the Pao Yuk Kong Auditorium.

Our President, Dr. Katherine Leung kicked off the event and welcome our audiences. The morning session explained what SDB is, how is it related to the dental profession, and the diagnosis and

investigation. We were privileged to have the following speakers: Dr. Siu Chung Fung, Dr. Angus Ho, Dr. Michael Chao and Dr. Crystal Ng from OMFS and Orthodontics, the United Christian Hospital introduced to us the importance of multidisciplinary management of obstructive SDB. Dr. Daniel Ng from the Hong Kong Sanatorium Hospital and Dr. Kah Lin CHAO from the North District Hospital focused on the diagnosis, pathophysiology and management in the perspectives of Paediatric and Adult Respiratory Medicine respectively. Next, we had Mr. Alex Sum from the United Christian Hospital introduce to us the procedure of sleep test and its interpretation. The morning session was completed by Dr. Natalie Leung explaining the role of ENT surgeons in SDB evaluations. This session was chaired by Dr. Jeni Ho and Dr. Ki Yung.

In the afternoon, the focus was on the interdisciplinary treatment of SDB. Dr. Vicky Tsui and Gu Min from The University of Hong Kong discussed the orthodontic treatment. Dr. Zion To, Dr. Ivan Ying and Dr. Teresa Lo from the United Christian Hospital presented the ENT and maxillofacial surgical treatments. Dr. Stephan Chan from the Hong Kong Children Hospital explained how myofunctional therapy could help with the management of SDB. This session was chaired by Dr. Kum Chun Sing and Dr. Sam Kim. In the end, we had a panel discussion which It was probably one of the best panel discussions I have attended over the years.

I would like to thank our speakers, moderators, members of the CDSHK scientific meeting committee and the council 2021-2022 and 2022-2023, college secretariats and the HKAM technical team for their collaborative efforts to make this webinar/ physical meeting run smoothly. I would also like to thank the attendants of this meeting; we have received positive feedback and many contributory comments which led to the part 3 of the Dental and Medical networking in the winter scientific meeting this year. 

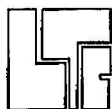

NOTES ON THE FINANCIAL STATEMENTS

1. GENERAL INFORMATION

The College of Dental Surgeons of Hong Kong ("the college") was incorporated in Hong Kong on 23 February 1993 as a company limited by guarantee. Every member of the college undertakes to contribute, if required, an amount not exceeding HK\$100 to the assets of the college in the event of its being wound up.

The address of the registered office of the college is Room 902, HKAM Jockey Club Building, 99 Wong Chuk Hang Road, Aberdeen, Hong Kong.

The college is engaged in promoting for the public benefit the advancement of knowledge in the field of dental surgery and its associated subjects and promoting training and research in dental surgery.

The financial statements are presented in Hong Kong dollars which is the same as the functional currency of the college.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the periods presented, unless otherwise stated.

a) Basis of preparation:

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standard for Private Entities ("HKFRS for Private Entities") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA") and the Hong Kong Companies Ordinance. These financial statements have been prepared under historical cost convention.

The preparation of financial statements in conformity with HKFRS for Private Entities requires management to make judgments, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenditure. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgments about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)

b) Property, plant and equipment:

Property, plant and equipment, other than construction in progress are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after the property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of comprehensive income in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of the property, plant and equipment, the expenditure is capitalised as an additional cost of that asset.

Depreciation on property, plant and equipment is calculated by the straight-line method to allocate cost to their residual value over their estimated useful lives as follows:

College gowns	20% per annum
Leasehold improvement	20% per annum
Furniture and fixtures	20% per annum
Office equipment	20% per annum

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

An item of property, plant and equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. The gain or loss arising on derecognition of the asset (calculated as the difference between the net sale proceeds and the carrying amount of the asset) is included in the statement of comprehensive income in the year in which the item is derecognized).

c) Inventories:

Inventories are stated at the lower of cost and net realizable value. Cost is calculated by using the weighted average method. Net realizable value is determined by management based on prevailing market conditions.

d) Impairment:

At the end of each reporting period, the college reviews internal and external sources of information to determine whether the carrying amounts of its tangible assets have suffered an impairment loss or impairment loss previously recognised no longer exists or may be reduced. If any such indication exists, the recoverable amount of the asset is estimated, based on the higher of its net selling price and value in use.

If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. Impairment losses are recognised as an expenditure immediately.

d) Impairment: (cont'd)

A reversal of impairment losses is limited to the carrying amount of the asset that would have been determined had no impairment loss been recognised in prior years. Reversal of impairment losses is recognised as income immediately.

Impairment loss on financial assets which is carried at amortised cost is measured as the difference between the asset's carrying amount the present value of estimated future cash flows discounted at the financial asset's original effective interest rate.

e) Revenue recognition:

Income from subscription and entrance fees is recognised on an accruals basis.

Income from meeting, course and examination is recognised upon completion of services provided.

Interest income is recognised as it accrues using effective interest method.

f) Related parties:

a) A person, or a close member of that person's family, is related to the college if that person:

- i) has control or joint control over the college;
- ii) has significant influence over the college; or
- iii) is a member of the key management personnel of the college or the college's parent.

b) An entity is related to the college if any of the following conditions applies:

- i) The entity and the college are members of the same group.
- ii) One entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).
- iii) Both entities are joint ventures of the same third party.
- iv) One entity is a joint venture of a third entity and the other entity is an associate of the third entity.
- v) The entity is a post-employment benefit plan for the benefit of employees of either the college or an entity related to the college.

f) Related parties: (cont'd)

b) An entity is related to the college if any of the following conditions applies: (cont'd)

vi) The entity is controlled or jointly controlled by a person identified in (a).

vii) A person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity).

viii) The entity, or any member of a group of which it is a part, provides key management personnel services to the group or to the group's parent.

Close members of the family of a person are those family members who may be expected to influence, or be influenced by, that person in their dealings with the entity.

g) Cash and cash equivalents:

For the purpose of the statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the college's cash management.

h) Retirement benefit costs:

The college joins a defined contribution retirement scheme under the Mandatory Provident Fund Schemes Ordinance (the "MPF Scheme") for those employees of the college.

The college's contributions to the MPF Scheme are made based on a percentage of the eligible employees' relevant income as defined in the Mandatory Provident Fund Schemes Ordinance. These contributions are expensed as incurred. The assets of the scheme are held separately from those of the college in independently administered funds.

i) Government grants:

Government grants are recognised in the statement of financial position initially when there is reasonable assurance that they will be received and that the college will comply with the conditions attaching to them. Grants that compensate the college for expenses incurred are recognised as revenue in the statement of comprehensive income on a systematic basis in the same periods in which the expenses are incurred. Grants that compensate the college for the cost of an asset are deducted in arriving at the carrying amount of the asset and consequently are recognized in the statement of comprehensive income over the useful life of the asset.
