PRESIDENT'S REPORT

First of all I would like to express my thanks to all councilors and committee members for their tireless work and efforts to fulfill the tasks and goals of our college. I also thank the Fellows and members for their continuous support. A special thanks goes to the outgoing councilor, Dr David O'Donnell, the Honor Editor of the College Newsletter for his dedicated and artistic work.

This year essential targets set by the College have finally been fulfilled. The training pathways for three 'new' specialties (endodontics, periodontology and prosthodontics) have been approved by the HKAM. During next year I hope that those colleagues who are under remedial training in those 'new' specialties should have undergone exit assessments, and that the first intermediate examinations in all six specialties will be conducted co-jointly with Royal College of Surgeons of Edinburgh in addition to the MGDS exams once a year starting from next year. The remaining exit assessments for the 'old' specialties were completed in November and three new fellows are to be admitted under this arrangement.

The first exit examination ever of the College was held in October 2001 in orthodontics. Those four pioneers were the first to fulfill the requirements laid down in the training pathways and are now to be admitted as fellows today. Congratulations! The exit examination of the College is scheduled for three candidates in Oral and Maxillofacial Surgery to be held in mid November.

Conjoint examinations were held in Paediatric Dentistry, orthodontics and MGDS this year. For the first time an examination targeted overseas candidates only, i.e. the examination in orthodontics was held for overseas candidates from PRC, Japan and Australia. It seems that the College in collaboration with the College of Surgeons of Edinburgh is consolidating its standing as an examination center in Asia. And I can tell you that one of the members of the examination group from Edinburgh informed me that the quality of the candidates sitting for the exam, in general were of definite superior quality to the candidates the RCSEd-examiner examined elsewhere.

It seems that the specialties in PRC seriously discuss setting clinical standards, the content

of the training courses, and examinations. This October I was invited to the Annual Meeting of the Chinese Society of Orthodontics to give a lecture on Teaching and Standards. The meeting was held in Shanghai and had attracted 500 participants. On the last pages in the abstract book the Regulations of the Membership in Orthodontics – our intermediate examination – was translated in full.

The participants seemed genuinely interested, encouraged by their President our own honorary fellow Professor Fu Min-Ku, to know as much as possible about the concept of specialist training and examinations adopted in Hong Kong. CD ROMs with examples of case presentations were also given to the Chinese Society of Orthodontics to be used a source of information and guidelines for its members.

Practically each year the College has invited prominent colleagues to become Honorary Fellows of our College, which is a way for us to show our appreciation for the work outstanding colleague have made to the profession and the College, and a way to extend the College's links outside Hong Kong. This year the College is most honored to see three new honorary fellows. Two of them are the current deans of the two most prominent dental schools in China, i.e. Professor Yu (Peking University) and Professor Zhang (Shanghai 2nd Medical University). They belong to new generation of distinguished academics who are very talented leaders in most dynamic period of dental education in China. Major changes when it comes to all aspects of education and facilities have occurred during their leadership at their home institutions, and more exciting developments are under way. The third Honorary fellow is Professor Trevor Burke, UK, who has been a most fantastic and tireless asset in building up the MGDS examinations here in Hong Kong.

The number of scientific meetings has increased to three per year, it means that any fellow by attending those quality meetings can secure more than half of the required CME points per year. This year the spring Scientific Meeting was on Ultrathin Veneers with Live Patient Demonstrations on Stage - for the first time ever in Hong Kong, the Autumn Scientific Meeting was on High Tech Ceramics in Dentistry, and the Winter Scientific Meeting today is on Implantology. All those events have been open for all members of the dental team, students and professional alike, a concept which seemed to have been well received. Next year the Spring Scientific Meeting will be on Interceptive Orthodontics (May 19, 2002). The Autumn Scientific Meeting will be on implantology-periodontology

and will be held in connection with the 20th Anniversary of the Dental Faculty (22 September 2002) and the Winter Scientific Meeting is set for November and will tentatively be on oral surgery, orthodontics and esthetics. The planning of the meetings to be held in 2003 and 2004 is ongoing, please contact the Scientific Meeting Chairman or any other Councilor if you have suggestions for the future scientific meetings.

The College Website is under continuous development and the College Council would welcome feedback from fellows and members.

Tonight the College is holding its first conferment of fellowship and annual dinner on Sunday November 18, at the Hong Kong Country Club (Aberdeen) the same day as the Annual General Meeting. It was felt that the College which wants to promote fellowship should be more active in organizing social events for its fellows. In this context I like to inform you that the HKAM is going to build a lounge for its fellows on the third floor in the HKAM building, with bar, café, library and gym., once the decision is made to go ahead the lounge it will be ready in three months. The cost is covered by generous donations. So sometime next year the fellows will have access to very nice venue for social inter-action within the HKAM building.

The service to the fellows and members is maintained also by our full-time executive secretary Ms. Ada Houn and her dedicated work.

I wish fellows, members and the College a successful year to come. It has indeed a privilege to serve you during the last year.

- ✧ We welcome the addition of Dr N Samman to our Specialty Board's membership this year. Dr Samman's contribution has given new impetus to our Board.
- ✧ The second diet of Conjoint Intermediate Examination with the Royal College of Surgeons of Edinburgh (MOS RCSEd) was held from 23rd – 29th November 2000 with Prof H Tideman at the helm as Chief Examiner. The Examiners from the HK College were Prof L K Cheung and Dr N Samman. Examiners from the Edinburgh College were Prof J Cowpe and Mr R Brown. A total of five candidates took the Examination. The following candidates were successful:

- ✧ Two diets of Exit Assessment in Oral and Maxillofacial Surgery were held on 26th March and 23rd October 2001. The Examiners were Prof L K Cheung, Dr Roch Lee and Dr N Samman. Dr Chow Kwok Fai and Dr Tam Kai Chung were the successful candidates. They were recommended subsequently to the College and Academy for admission as Fellows.
- ✧ The Inaugural diet of Exit Examination is scheduled to be held on 12th and 16th November. A total of 3 candidates, having completed their 3 years of Higher training, will be participating. The Examiners will be the same as that of the Exit Assessment.

2 Specialty Board in Orthodontics

During the year 2000-2001 the specialty board in orthodontics organised the following examinations:

- ✧ Two diets of the Conjoint Membership Examination in Orthodontics with our sister college The Royal College of Surgeons of Edinburgh were held from 4th – 5th December, 2000 (Part 1) and from 22nd to 27th October 2001 (Parts 1 & 2). The candidates came from the Asian-Pacific region namely Australia, China, Egypt, Japan, Hong Kong, Malaysia and Singapore. The examination diet in October 2001 was the largest of its kind so far, with 19 candidates in total participating in the two parts.
- ✧ Exit assessment in orthodontics was held on 24th October 2001. The two successful candidates are the last ones who had completed the remedial training under bylaw 16 of the HKAM, and we warmly welcome them in joining the specialty of orthodontics.
- ✧ Exit examination in orthodontics was held on 24th October 2001. The four candidates who passed are the first group of candidates who fulfilled the 6 years training pathway programme in orthodontics. Again, the Board congratulate them in their diligent efforts and successful in completion of the training programme, setting a standard for the future and be recognized as a specialist in the specialty of orthodontics.
- ✧ Members of the specialty board have requested all trainees to complete their registration with the board and to take appropriate examinations and clinical training. At present, one candidate is registered and undergoing training in the Higher Training and four candidates registered in the Basic Training programme in orthodontics.
- ✧ Conjoint Section A and B MOrthRCSEd/Intermediate FCDSHK examination in Orthodontics has been scheduled in November 2002.

4 Specialty Board in Endodontics

With the acceptance of Endodontics as a specialty within the College of Dental Surgeons by the Academy of Medicine, the Special Board in Endodontics was formally inaugurated on February 1, 2001. Another applicant was deemed to require “remedial” training and will be assessed prior to admission. The projected number of trainees in the Specialty is 5 by the end of 2001. No intermediate or exit examination was planned for 2001.

5 Specialty Board in Periodontology

- ✧ The Academy has officially recognized Periodontology as a Specialty under our College on 18 January 2001. The Specialty Board in Periodontology was subsequently appointed by our College Council and held its first meeting on February 2001.

- ✧ Currently we have three candidates under higher training and two having basic training. The first FCDSHK Intermediate Examination in the Specialty of Periodontology will be held in 2002.

 - ◆ Setting up the Intermediate Examination in Prosthodontics of the College as a MRD Conjoint Examination with the Royal College of Surgeons of Edinburgh by November, 2002;
 - ◆ Encouraging junior trainees to join the Specialty training for Prosthodontics;
 - ◆ Acquiring Specialist Status recognition by the Dental Council for fellows in the Specialty of Prosthodontics through College Council.

7 Subcommittee on Education and Examinations for General Dental Practitioners (SEEGDP)

The Vocational Training Pathway in Primary Dental Care has now been in place for two and a half years. Following another successful diet of Conjoint examination of Membership in General Dental Surgery (MGDS) of The College of Surgeons of Edinburgh and The College of Dental Surgeons of Hong Kong, there are now 18 local dentists who have obtained their MGDS qualifications in Hong Kong.

During the past year, the Subcommittee has organized regular evening revision seminars for candidates for both parts of the examination. Members of the task force for the MGDS examination have also worked tirelessly in many areas of continuing professional development. Their efforts have included working in journal study clubs, conducting product and equipment evaluation and research (PEER), mentoring trainees, and providing guidance for candidates in preparing for their examinations. •

The Conjoint MGDS examination is held annually in November. The next examination will be from 19 - 22 November, 2001, when 7 candidates will take Part I and another 6 Part II.

The Subcommittee has reviewed the training pathway, and is currently developing a junior diploma and promoting continuing education for young graduates. The format and the scope of the new diploma are being formulated with the aim of taking into considerations the most recent developments in dental colleges overseas, which are running similar programmes.

Finally, the Subcommittee would like to take this opportunity to thank the Education Committee and the Council for their generous support in the course of the past year.

Both Drs. Chow Tak Kun and Kenneth Hui have completed their 3-year term of office in March 2001. They have been re-nominated to, and re-appointed by, the College Council, for another 2-year term of office commencing April 2001. From now on, all members will be on 2-year terms. Hence at any time of the year, at least half of the members in our Subcommittee will have some experience in the field of CME activities, as a mean of quality assurance to serve all our Fellows.

2. CME activities in the year 2001 :

Up to October 15, 2001, our CME Subcommittee has pre-approved, endorsed and accredited a total of **236** scientific meetings, both locally and overseas.

3. CME Cycles :

For ease of reference and accreditation of CME points, our Subcommittee has taken the liberty to classify Fellows into "batches", according to their respective period of CME cycle.

3.1 Batch 1 - CME Cycle from 01.01.2000 to 31.12.2002

A total of 101 Fellows are currently in this batch; all of them are in their second year of the second 3-year CME cycle. The following table is a summary of their CME scores :

TREASURER'S REPORT

The financial statements for the year ended 31st March 2001 recorded a surplus of 0.4M, compared to 0.28M for the previous year. While our major source of income still came from members' subscriptions, the increasing frequency and popularity of our scientific meetings, MGDS revision courses and Conjoint Examinations had contributed significantly to this year's surplus. The operating income generated from these activities was 0.36M compared to 0.12 M for last year.

Operating expenses has increased by about 20%. The employment of a full time secretarial staff had incurred a modest increase in salaries and related expenses. However, the workload of our various committee members had been much alleviated, thus allowing the College affairs to be run more smoothly and efficiently. The other major operating expense was management fees paid to the Academy of Medicine which has remained the same as last year.

I would like to take this opportunity to thank our Honorary Auditor, Messrs. Li Tang Chen & Co. for auditing our accounts and our Council members for their advice and guidance, without which the task would have been impossible.

In my opinion the financial statements give a true and fair view of the state of the college's affairs as at 31st March, 2001 and of its surplus for the year then ended and have been properly prepared in accordance with the Companies Ordinance.

NOTES ON THE FINANCIAL STATEMENTS

1. STATUS OF THE COLLEGE

The college was incorporated in Hong Kong on 23rd February, 1993 as a company limited by guarantee. Every member of the college undertakes to contribute, if required, an amount not exceeding HK\$100 to the assets of the college in the event of its being wound up.

The college is engaged in promoting for the public benefit the advancement of knowledge in the field of dental surgery and its associated subjects and promoting training and research in dental surgery.

2. PRINCIPAL ACCOUNTING POLICIES

a) Basis of preparation:

The financial statements are prepared under the historical convention, and in accordance with all applicable Statements of Standard Accounting Practice and Interpretations issued by the Hong Kong Society of Accountants, accounting principles generally accepted in Hong Kong and the requirements of the Hong Kong Companies Ordinance.

b) Revenue recognition:

Income from subscription and entrance fees is recognized on an accruals basis.

Income from meeting, course and examination is recognized upon completion of services provided.

Sales of college ties are recognized when college ties are delivered.

Interest income is recognized on a time proportion basis.

c) Depreciation on fixed assets:

Fixed assets are depreciated on the straight line method at the following rate:-

College gowns	20% per annum
Leasehold improvement	20% per annum
Furniture and fixtures	20% per annum
Office equipment	20% per annum

d) Inventories:

Inventories are stated at the lower of cost and net realizable value. Cost is calculated by using the weighted average method. Net realizable value is determined by management based on prevailing market conditions.

2. PRINCIPAL ACCOUNTING POLICIES (CONT'D)

e) Related parties:

Parties are considered to be related if one party has the ability, directly or indirectly to control the other party, or exercise significant influence over the other party in making financial and operating decisions. Parties are also considered to be related if they are subject to common control or common significant influence. Related parties may be individuals or entities.

f) Cash equivalents:

Cash equivalents are short-term, highly liquid investments which are readily convertible to known amounts of cash without notice and which were within three months of maturity when acquired.
