#### PRESIDENT'S REPORT

First of all I would like to thank all councilors and committee members for their devoted work to fulfill the tasks and goals for our College. I also thank all fellows for their support, as well as Ms Ada Houn, the College Executive Secretary, for her dedicated service.

During the past year the College has arranged examinations in various dental specialties adding new fellows to our ranks, strengthening the specialist service provided to the community. The specialty examinations comprise both an intermediate examination run conjointly with the Royal College of Surgeon of Edinburgh, and an exit examination. This year the College is holding conjoint examinations together with RCSEd in Oral and Maxillo-facial Surgery, Orthodontics, Prosthodontics and Endodontics, the two latter 'new' specialties are holding the examinations for the first time. However, the examination procedures in some specialties still remain to be fully implemented, and this expected to take places next year. By-law 16 allows for the admission of fellows to the College and the Academy after fulfilling the remedial training and exit assessment, but those people who are in this category and the respective specialty boards have to be reminded that this option will expire at the end of December 2004.

This year the College has arranged its usual three Scientific Meetings and courses which all seemed to have been attractive and popular among members of the dental community. Those meeting which were held in the beautiful premises of the Hong Kong Academy of Medicine Building give the community convenient access to quality – non commercial – programs comprising lectures given by a mixture of colleagues from the various dental disciplines who were invited from overseas and the region. The meetings have also served as a forum for our own colleagues to reach out with their messages to the dental community. The recent Scientific Meeting with Professor Claus Lang, from Switzerland as the speaker, was held as conjoint function with the Dental Faculty to mark its 20<sup>th</sup> Anniversary, and attracted well over 200 participants.

The third and final Scientific Meeting of this year will be a full day meeting which will be held on Sunday November 17, in Hong Kong Academy of Medicine Building. The theme will be: "Implants – A Versatile Aid to Quality Care in Dentistry". This symposium will be on implants as well on alternative treatment options. Two of the speakers, Professor

Brånemark, from Sweden and Professor Fan (Endodontics), from China have also been invited to become honorary fellows of the College (see below). The other overseas speaker will be Dr Isaksson (Oral Maxillofacial Surgery), from Sweden and Dr Sugawara (Orthodontics), from Japan. The three local speakers will be Professor Anne McMillan, Dr T W Chow and Dr Alex Chan. The day before the Scientific Meeting, that is on Saturday November 16, the College hosts its annual dinner for fellows, their spouses and friends, and invited guests at the Hong Kong Country Club. The inauguration of honorary fellows will take place at this event. Do not miss this event, which in addition to a gourmet dinner will feature a Philippino dance band.

During the week before the upcoming Scientific Meeting, on Wednesday November 13 the College is organizing jointly with HKDA a full-day continuing education course to be held in Lecture Theatre I at Prince Philip Dental Hospital. There will be two reputable international speakers Professor Athanasios, from Greece (Orthodontics) and Associate Professor Isaksson (Oral Maxillofacial Surgery), from Sweden.

The College is still working together with representatives from HKAM, to further develop the training pathways for general dental practitioners, possibly leading to recognition as a specialty.

Unfortunately, despite the mutual efforts by the President of the HKDA Dr John Ling, the Chairman of the Dental Council of Hong Kong Dr Jeffrey Tsang, the President of the HKAM Dr C H Leong, Hon Dr Lo and myself the Dental Ordinance has still not been changed. I feel responsible persons in the HKSAR administration as well as Legco have not made any visible efforts to deal with this issue, which is long overdue. It is understandable that those bodies have to assign priorities, but to postpone this important issue which was prepared years ago, can only be considered as neglected, and a lack of respect for our profession and our patients.

Trainees of all specialties are reminded that they are required to register with the College to get recognized and to enjoy the specific privileges offered to trainees.

Finally, next year is the 10<sup>th</sup> Anniversary of the College (and the Academy), which our Council has decided to mark and to celebrate by arranging a four day (October 31 to

November 3, 2003) international congress on "Evidence Based Advanced Dentistry". The Chairman of the Organizing Committee is Dr Michael Tsui and the Secretary is Dr T C Wong. You have all received the first announcement via the mail. The success of this event depending on everyone of us, so please give your support by participating together with your staff in this event. Please inform your friends and colleagues outside Hong Kong about this event (for this purpose come extra flyers have been enclosed with this report – if you need more flyers please contact Ms Houn on phone (852) 2871 8866, fax (852) 2873 6731 or e-mail cdshk@hkam.org.hk and Ms Houn will mail additional flyers to you). If you attend a professional meeting outside Hong Kong please take some flyers with you and promote our meeting, making it to a real success... if you have contacts with the trade please ask them to contact the CDSHK secretariat. Thank you for your kind cooperation and support.

I wish all fellows, members and the College a successful year to come. It has indeed been a privilege to have served you during the past year.



- The Committee met on 31 January, 2 May, 25 July and 10 October during the year to receive reports from the various Specialty Boards and Committees;
- The lists of Fellows, supervisor/trainers and trainees of each specialty have been updated;
- The College planned to establish a new specialty in Family Dentistry. The training pathway for this new specialty has been drafted for consultation with the Academy. More discussions would be required
- Negotiation was carrying out for a conjoint MFGDP examination with the Faculty of General Dental Practitioners, Royal College of Surgeons of England. The Council met the Dean of the Faculty, Dr R RajaRayan during his visit to Hong Kong together with representatives of the Hong Kong Dental Association and the Faculty of Dentistry, HKU. Both Colleges decided that a conjoint examination would be the best way forward and went ahead with the preparation of a Memorandum of Understanding. It is expected that a conjoint Part II MFGDP examination could be held next year.
- The respective specialty board and committee would report their activities separately.

#### 2 Specialty Board in Paediatric Dentistry

The following were highlights of our activities during the year 2001-2002:

- The third Conjoint Examination in Paediatric Dentistry with the Royal College of Surgeons of Edinburgh was held in October 2001. There were two candidates sitting for the Part I examination and there were eight candidates sitting for the part II examination. Both candidates were successful in the Part I examination and six candidates were successful in the part II examination.
- The Specialty Board conducted its first Exit Examination in January 2002. One candidate sat and passed the examination.
- The Speciality Board is planning for the fourth Conjoint Examination in Paediatric Dentistry with the Royal College of Surgeons of Edinburgh in November 2003.

#### **Specialty Board in Orthodontics**

During the year 2001-2002 the specialty board in orthodontics arrange the following activities and examinations:

- The Conjoint Membership Examination in Orthodontics with our sister college The Royal College of Surgeons of Edinburgh will be held from 14<sup>th</sup> – 16<sup>th</sup> November 2002 (Part 2). We anticipated 17 candidates from the Asian-Pacific region namely China, Japan, Hong Kong, Taiwan and Thailand.
- Exit examination in orthodontics will be held on 14<sup>th</sup> November 2002 for one candidate.
- The specialty board has requested all trainees to complete their registration with the board and to take appropriate examinations and clinical training. At present, two candidates were registered and undergoing training in the Higher Training and five candidates were registered in the Basic Training programme in orthodontics.
- Conjoint Section A and B MOrth RCSEd/Intermediate FCDSHK examination in Orthodontics has been scheduled in November 2003.

Dr Frederick Chu passed his MRD examination and was accepted as a higher trainee.

Conjoint Examination between the MRD of the Royal College of Surgeons of Edinburgh (RCSEd) and the Intermediate Examination of the Prosthodontics Fellow was established. The College has also received the reply from the RCDSEd that candidates with MDS from HK could be exempted from Part I of the Specialty Membership Diploma in Restorative Dentistry. Letters were sent to all past MDS candidates to inform them about the exemption from Part I MRD examination.

At the time of writing this report, the specialty has 7 higher trainees, 1 intermediate trainee and no junior trainee. The Specialty will be holding its first diet of the Intermediate Examination in November 2002 and the Exit Examination in the early 2003.

#### 6 Specialty Board in Periodontology

- Since Periodontology is recognized as a specialty in our College (2001), the Specialty Board in Periodontology has endorsed 10 of our fellows as FCDSHK (Périodontology).
- Currently we still have three trainees under By-law 16, they will have to take an exit assessment upon completion of their "remedial" training prior to admission.
- Under the guidance of our Supervisor of training, Dr E F Corbet, a total of 5 trainees are having Basic Training. Two of them have finished the Advanced Diploma in Periodontology course and are eligible to have the Intermediate Examination.
- Together with the specialties in Endodontics and Prosthodontics, we have finalized the arrangement with the Royal College of Surgeons of Edinburgh to run a Conjoint CDSHK/MRD (RCS Ed) Examination in Hong Kong. This is the Intermediate Examination for the specialist training pathway in Periodontology. Two of our trainees are expected to take the Examination in November 2003.

#### 7 Board of General Dental Practice

Life-long continuing professional developments and education for General Dental Practitioners are becoming more complex. The volunteer Continuing Professional Education program introduced this year will eventually become mandatory for the practicing dentists in Hong Kong SAR. The pivotal role of the College in providing training and guidance for GDPs is all the more obvious and important.

To meet this increasing demand, the Subcommittee for Education and Examination of General Dental Practitioner reinforced its commitments and was renamed Board of General Dental Practice in June 2002 to reflect more fully the scope and activities that it conducts.

#### **♥** Conjoint Membership in General Dental Surgery

The 2001 diet of the Conjoint Membership in General Dental Surgery Examination with the College of Surgeons of Edinburgh concluded with a high pass rate with three of the four candidates being successful in the Part II examination in November. This brings the total number of MGDS RCS(*Ed*) holders in Hong Kong SAR to 23. The mentorship scheme that provides support to the candidates has again proved to be successful.

#### **☼** Training Pathway

The Board and its Task Force worked tirelessly in constructing a Vocational Training Pathway of Family Dentistry. With the approval of the Council of The College of Dental Surgeons of Hong Kong, the recommendations will soon be submitted to the Hong Kong Academy of Medicine for the establishment of the subspecialty of Family Dentistry within The College of Dental Surgeons of Hong Kong.

#### **Continuing Education Courses**

Members of the Task Force have also immersed themselves in organizing continuing education courses for both MGDS candidates and general dental practitioners. An innovative series of lectures and hands-on courses was designed, and included topics ranging from infection control, emergency management and clinical dentistry. All were well attended and received.

#### **☼** Practice Guidelines

The Task Force members have also started constructing the Foundation of Good Practice guidelines that includes clinical audit, quality assurance and clinical governance.

#### **□ Post-MGDS** Activities

- i) **Practice-based Research**: The PEER clinical research group successfully conducted an evaluation of an innovative composite resin. The results were published in the April 2002 issue of the journal of *Primary Dental Care* entitled *Research in General Dental Practice: evaluation of the clinical use of a new composite system by general dental practitioners*.
- ii) **Journal Club**: A group of MGDS holders regularly holds regular meeting in the evenings to exchange views and knowledge of the latest advances in dentistry.
- iii) **Hospital Dentistry**: An opportunity arose whereby MGDS holders may attend regional hospitals, with the support of the Hospital Authority of Hong Kong, to gain experience in Hospital Dentistry and Special Needs Dentistry.

#### **8** Continuing Medical Education Committee

#### 1. A change of name:

The previously known CME Subcommittee has been renamed as CME Committee, approved by the College's Council. The change was deemed reasonable and essential because of the diversity and nature of works involved, and has long been independent from the Education Committee.

Dr Leung Tat Ming was our new Committee member who was nominated to, and appointed by the College Council, for a 2-year term commencing April 2002. With the current composition of members, we have confidence that our Committee could further improve the quality of service for all our Fellows.

While on the subject of service, we were indeed in debt to Dr Alec Tam, who served our Committee for the past two terms (4 years). He resigned from our Committee because he himself has other commitments; yet he still agreed to serve our Committee as an advisor should we encounter difficulty in assessing meetings associated with Orthodontics. His unfailing contributions in various matters relating to CME should be acknowledged and appreciated.

#### 3. CME activities in the year 2002:

Up to October 15, 2002, our CME Committee has pre-approved, endorsed and accredited a total of **314** scientific meetings, both locally and overseas.

#### 4. CME Cycles:

Since early 2001, our Committee has taken the liberty to classify Fellows into "batches", according to their respective period of CME cycle.

#### 4.1 Batch 1 - CME Cycle from 01.01.2000 to 31.12.2002

A total of 100 Fellows are currently in this batch; all of them are in their third year of the second 3-year CME cycle. The following table is a summary of their CME scores:

#### 5. Membership & Learning Management System (MLMS)

The initial MLMS was launched in September 2002 and our College was one of the five selected Colleges to be involved in the pilot stage. Hopefully, by end of March 2003, all colleges would be covered under the MLMS.

To make the system functional and meaningful, we need your support to submit your CME activities promptly and consistently at regular intervals.

6. Handbook on Continuing Medical Education - second edition.

Our Committee is still in the process of preparing a second edition of the Handbook on CME, with quite a few suggestions from various sources received, including those from our own Fellows. Hopefully, it will be available from the Printer for all Fellows by early next year. Meanwhile, should you have any further comments, please do not hesitate to contact me, preferably before end of November 2002, so we can have the time to make further amendments. All constructive ideas will be considered seriously.

#### TREASURER'S REPORT

#### NOTES ON THE FINANCIAL STATEMENTS

#### 1. STATUS OF THE COLLEGE

The college was incorporated in Hong Kong on 23<sup>rd</sup> February, 1993 as a company limited by guarantee. Every member of the college undertakes to contribute, if required, an amount not exceeding HK\$100 to the assets of the college in the event of its being wound up.

The college is engaged in promoting for the public benefit the advancement of knowledge in the field of dental surgery and its associated subjects and promoting training and research in dental surgery.

#### 2. ADOPTION OF STATEMENTS OF STANDARD ACCOUNTING PRACTICE

In the current year, the college has adopted for the first time new and revised SSAPs issued by the Hong Kong Society of Accountants. The new and revised SSAPs have introduced revised disclosure requirements which have been adopted in these financial statements.

The adoption of these new and revised SSAPs has no material impact on the amounts reported for the current or prior periods.

#### 3. PRINCIPAL ACCOUNTING POLICIES

#### a) Basis of preparation:

The financial statements are prepared under the historical convention, and in accordance with all applicable Statements of Standard Accounting Practice and Interpretations issued by the Hong Kong Society of Accountants, accounting principles generally accepted in Hong Kong and the requirements of the Hong Kong Companies Ordinance.

#### b) Revenue recognition:

Income from subscription and entrance fees is recognised on an accruals basis.

Income from meeting, course and examination is recognised upon completion of services provided.

Sales of college ties are recognised when college ties are delivered.

Interest income is recognised on a time proportion basis.

#### c) Depreciation on fixed assets:

Fixed assets are stated at cost less accumulated depreciation and any impairment losses.

Fixed assets are depreciated on the straight line method at the following rate:-

College gowns20% per annumLeasehold improvement20% per annumFurniture and fixtures20% per annumOffice equipment20% per annum

#### 3. PRINCIPAL ACCOUNTING POLICIES (CONT' D)

#### d) Inventories:

Inventories are stated at the lower of cost and net realisable value. Cost is calculated by using the weighted average method. Net realisable value is determined by management based on prevailing market conditions.

#### e) Related parties:

Parties are considered to be related if one party has the ability, directly or indirectly to control the other party, or exercise significant influence over the other party in making financial and operating decisions. Parties are also considered to be related if they are subject to common control or common significant influence. Related parties may be individuals or entities.

#### f) Cash equivalents:

Cash equivalents are short-term, highly liquid investments which are readily convertible to known amounts of cash without notice and which were within three months of maturity when acquired.
