President's Report

I was most privileged to be elected as President during the Council Meeting in December 2003 and to work with a team of dedicated office-bearers and councilors this year. Your Council held a total of eight meetings since then. Apart from dealing with the routine matters of dental specialist training and examinations, much effort have been spent on external relations and public education to promote the College and the dental specialties to the public as well as the medical and dental colleagues. Our representatives have appeared in the programs of TVB and RTHK during May and June. Three oral health messages provided by the College were broadcasted by RTHK in September and another three messages will be broadcasted in December. Articles introducing the dental specialties were published in Ming Pao Daily one by one on a weekly basis from October onwards. As a result of an article in the Chinese dental journal "Dental Progress", most dentists in China have heard of the College and the specialties. The College also participated in the Faculty Open Day on 28 March and had a booth in the trade exhibition during the 26th Asia Pacific Dental Congress from 28 May to 1 June disseminating information to the dental colleagues and students. The HKDA has kindly invited me to speak on the topic "The College and the Profession" at its October monthly meeting. I represented the College at the 38th Singapore-Malaysia Congress of Medicine in August and was conferred as Fellow of Academy of Medicine Singapore together with the Presidents of 16 other colleges from various parts of the world. This should not be considered as a merit of one person but rather as recognition of our College as a whole internationally.

As a support to HKDA and the 26th Asia Pacific Dental Congress that provided a wide range of CME activities for our Fellows, we did not hold the Spring Scientific Meeting this year. Professor Hee-Moon Kyung from Korea was our speaker at the Autumn Scientific Meeting successfully held on 19-20 September. The topic was "Micro-implant Anchorage in Orthodontic Treatment". There were about 70 participants at the lectures and live demonstration and over 30 participants attended the workshop held on the following day. The Winter Scientific Meeting will be held on 21 November. Professor Markus Haapasalo from Canada and Dr Roderick I Marshall from Australia will speak on the topic of "Perio-Endo Interrelations".

The Fellowship Conferment Ceremony and Annual Dinner will be held in the evening of 21 November. A total of nine new Fellows will be admitted and another seven Members will receive their certificates. The College will also admit four new Honorary Fellows this time.

It is a special privilege of the College to have one of our Past-President, Professor Ian Davies admitted as Honorary Fellow of the Academy. He will be conferred at the AGM of the Academy on 17 December together with Professor Huang Jiefu, Deputy Minister of Health of China. I would urge all Fellows and Members of the College to support this important occasion of the College.

In response to the concern of dental colleagues in the general practice on the training pathway of our new specialty of Family Dentistry, a special Task Force will be established with representatives from HKDA to look into ways that make the pathway more practicable for colleagues in private general dental practice to join without affecting the standard.

As I emphasized in my presentation titled "The College and The Profession" at the October monthly meeting of the HKDA, the College, as one of the constituent college of the Hong Kong Academy of Medicine, not

only ensures professional autonomy in the standard of specialist oral health care but also upholds the profession as the only expert in the field. Nevertheless Dr C H Leong, President of the Academy, pointed out that "as the only statutory body representing the medical and dental professions the Academy have not been allowed to participate more deeply in policy formulation of the government in relation to health, health care and related matters". Looking into the future, our College should support the Academy in its effort to urge the government to have this rectified.

Once again I would like to express my deepest gratitude to members of the Council, specialty boards and various committees for their invaluable contribution to the College during the year. Special thanks should go to Ada and other staff for their work to ensure the smooth operations of the activities of the College. Finally I would also like to thank all the Fellows and Members for their support.



- ✧ The Committee met on 4 December 2003, 13 February, 28 June and 14 October 2004 to receive reports from specialty boards and the CME Sub-committee.
- ✧ The College is planning the addition of a new specialty, namely Community Dentistry to the existing seven specialties. The training pathway is currently being drafted by Professor Edward Lo.
- ✧ The Committee is, at the request of the Academy of Medicine to all its fifteen Colleges, reviewing the minimum length of specialist training required for Dental Surgery.
- ✧ Discussion is underway to consider holding conjoint intermediate examinations at an earlier time to allow trainees to receive their diplomas soon after their examinations when the College of Surgeons of Edinburgh holds its Diploma Ceremony in the month of November in Hong Kong.
- ✧ The fees for conjoint examinations will be adjusted upwards slightly in 2005.

2. Meetings

The Specialty Board formally met twice in 2003 - 2004 in addition to numerous electronic communications discussing matters of the Specialty. Two enquiries (former graduates from the Faculty of Dentistry, HKU) to join the training pathways were considered and the applicants were advised of the pathway that had been promulgated when the Specialty was established. The issue of the use of Specialist Titles was also raised and the Board welcomed the CDSHK's effort to publicize the various dental specialties in Hong Kong.

3. Examinations

A Conjoint MRD RCSEd/CDSHK intermediate examination was held in November 2003 which was taken by two candidates. One has successfully passed and proceeded to Higher Training in the specialty. The other candidate has been allowed to retain the passing marks in some components and will be re-sitting for the upcoming conjoint examination.

The first Exit Examination in the endodontic specialty will take place in November 2004, for which there will be one candidate.

4. Other activities

The Board has been working with the Specialty Board in Periodontology in organizing the Winter Scientific Meeting in November 2004. The theme is on Perio-Endo Inter-relations.

The Board also participated in the HKU Faculty of Dentistry's postgraduate Open Day held on 28 March 2003 to promote the specialty and explain the training pathway to prospectus applicants. A total of 3 MDS students have started their study who may become trainees of the specialty in due course.

Some health messages in Chinese have been prepared by the Board for publicity and public education.

✧ Exit assessment and admission of first batch of Family Dentistry fellows

During the year 2003 - 2004, seven higher trainees completed and passed the exit assessment. Six of them were conferred the College Fellowship on 19th November 2003. There will be a further diet of exit assessment soon after the end of November 2004. The assessors for this diet will be Drs Bill Yan, T W Chow, William Yung, Gary Cheung and K Y Zee.

✧ The introduction of the new specialty to the dental profession and the general public

With the help of the College and the Faculty of Dentistry, a publicity exercise aimed at the public and the dental profession was launched to introduce Family Dentistry as the newest Specialty of the College of Dental Surgeons of Hong Kong. The exercise included mass media coverage by RTHK I, Sing Pao, Ming Pao, Hong Kong Economic Press and TV Jade. College Handbooks on the pathway synopsis and first year trainee program were sent to all registered dentists. An orientation seminar was held as one of the College collaborative activities during the Open Day of the Faculty of Dentistry, The University of Hong Kong on 28th March 2004 at the Prince Philip Dental Hospital.

✧ Training

The first training cycle commenced in September 2004 and there are 7 basic trainees enrolled in the first year trainee program. All Fellows of Family Dentistry are involved in this training program on an honorary basis as teachers and trainers.

✧ Intermediate Examination

There were two Conjoint MGDS Part II candidates in year 2003 and both of them were unsuccessful. One candidate will be sitting for the Conjoint MGDS Part I in November 2004.

- ✧ The Conjoint Membership Examination in Orthodontics with our sister college The Royal College of Surgeons of Edinburgh will be held from 18th - 20th November 2004 (Part II). We have 8 candidates from the Asian-Pacific region namely China, India, Malaysia, Thailand and Netherlands to participate the MOrth examination.
- ✧ The specialty board has requested all trainees to complete their registration with the board and to take appropriate examinations and clinical training. At present, five candidates were registered and undergoing training in the Higher Training and five candidates were registered in the Basic Training programme in orthodontics.
- ✧ Dr Wong Fung Ki completed his higher training and passed the Exit Examination in May 2004 and shall be nominated as fellows of the College and Academy.
- ✧ The Conjoint Membership Examination in Orthodontics 2003 was conducted in November 2003 and all 10 candidates passed. The Conjoint MOrth Examination Medal recipient was Dr Darren Townsend, Adelaide.

Drs Leung Tat Ming and Zee Kwan Yat have been nominated to, and approved by, College Council, to be members of the CME Subcommittee for another 2-year term commencing April 2004.

So far all members have assisted me in running the CME Subcommittee effectively and efficiently; I wish to take this opportunity to thank them all for their continual support, efforts and contributions.

2. CME activities for the first nine months of the year 2004:

Up to the end of September, 2004, our CME Subcommittee has vetted, pre-approved, endorsed and accredited more than 345 scientific meetings, locally and overseas.

3. CME Cycles:

Since early 2001, all Fellows were grouped under "batches" for ease of administration, according to their respective period of CME cycle. With 5 Fellows who were admitted to the Academy in 2004, they were grouped as the 12th batch, and their CME cycle commenced from 1.7.2004 onwards. We have a total of 173 Fellows who are currently undertaking CME activities and being served by our CME Subcommittee.

Since it is the Academy's decision to have all Fellows of all Colleges to start the same CME cycle commencing January 1, 2005, hence our CME Subcommittee has the obligation to re-define the appropriate duration for Fellows belonging to various batches to conclude their respective cycles by December 31, 2004, by adjusting the CME requirement on a pro-rata basis.

With a cut-off date on September 30, 2004, the subsequent paragraphs illustrate the CME scores, and the respective percentages, among these twelve batches.

3.1 Batch 1 – CME Cycle from 01.01.2003 to 31.12.2004 (Cycle 3):

A total of 97 Fellows are in Batch 1, they are towards the end of their adjusted third CME cycle (with a duration of 2 years), and they have a target CME score of 60 points to meet. Their respective CME scores can be tabled as follow:

4. Review of the Voluntary Continuing Medical Education (CME) Programme for Practising Dentists (Dental Council of Hong Kong)

There were a total of 181 Dental Surgeons enrolled for the Voluntary CME programme for Practising Dentists, and our College continued to serve as one of the Administrators of the programme. The CME requirement for each and every enrollee is 15 CME points per year, or a total of 45 CME points per 3-year cycle.

For the period of from July 1, 2002 to June 30, 2004 (two years) the profile of CME points attained by participating dentists can be summarized in the following tables:

5. Handbook on Continuing Medical Education – second edition.

Treasurer's Report

With the effort of my predecessor, Dr Jason Cheng, the College has built a solid ground financially to continue on-going programs and to tackle future needs. At the beginning of my first year as the Honorary Treasurer, we were very concerned how to make our investment. After lengthy discussion, the Council decided to adopt a conservative policy.

There had been no increase in annual subscription in the last year. And membership subscriptions and surplus from our successful scientific meetings continued to be the major sources of our revenue.

In this year, the College incurred a deficit in the account. It was related to an unusual expense for the settlement of the expenses for the Conjoint Examinations in 2001, 2002 and 2003, and the addition of a secretariat staff and their salary adjustments, and inflationary increases in recurring operating expenses. The financial reserve of the College has been maintained by a sum of around 2.6 million. This should become a strong foothold for the College.

In order to promote fellowships, the Council has approved to invite all fellows to the Annual Dinner and Conferment Ceremony in 2004 at the College's expenses.

I would like to express our gratitude to our Honorary Auditor, Messrs. Li, Tang, Chen & Co. for their professional advice and services in the last year. I would also like to thank our Manager, Miss Ada Houn for her excellent secretarial assistance.

NOTES ON THE FINANCIAL STATEMENTS

1. STATUS OF THE COLLEGE

The college was incorporated in Hong Kong on 23rd February, 1993 as a company limited by guarantee. Every member of the college undertakes to contribute, if required, an amount not exceeding HK\$100 to the assets of the college in the event of its being wound up.

The college is engaged in promoting for the public benefit the advancement of knowledge in the field of dental surgery and its associated subjects and promoting training and research in dental surgery.

2. PRINCIPAL ACCOUNTING POLICIES

a) Basis of accounting:

The financial statements have been prepared in accordance with Hong Kong Statements of Standard Accounting Practice, accounting principles generally accepted in Hong Kong and the disclosure requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention.

In the current year, the company adopted the following revised Statement of Standard Accounting Practice ("SSAP") issued by the Hong Kong Society of Accountants which became effective for accounting periods commencing on or after 1st January, 2003:

SSAP 12 (Revised) Income taxes

The adoption of this revised SSAP has no material impact on the amounts reported for the current or prior years.

b) Revenue recognition:

Income from subscription and entrance fees is recognised on an accruals basis.

Income from meeting, course and examination is recognised upon completion of services provided.

Interest income is recognised on a time proportion basis.

c) Depreciation on fixed assets:

Fixed assets are stated at cost less accumulated depreciation and any impairment losses.

Fixed assets are depreciated on the straight line method at the following rate:-

College gowns	20% per annum
Leasehold improvement	20% per annum
Furniture and fixtures	20% per annum
Office equipment	20% per annum

2. PRINCIPAL ACCOUNTING POLICIES (CONT'D)

d) Inventories:

Inventories are stated at the lower of cost and net realisable value. Cost is calculated by using the weighted average method. Net realisable value is determined by management based on prevailing market conditions.

e) Related parties:

Parties are considered to be related if one party has the ability, directly or indirectly to control the other party, or exercise significant influence over the other party in making financial and operating decisions. Parties are also considered to be related if they are subject to common control or common significant influence. Related parties may be individuals or entities.

f) Cash equivalents:

Cash equivalents represent assets similar in nature to cash, which are not restricted to use.
