President's Report

2005 was quite a busy year for the College. A total of 11 Council meetings were held since the last AGM in 2004. Needless to say, the usual items of the agendas centred among the training, accreditation, and examination of the dental specialties. As a special note, the meeting in January was very much *graced* by the visit of the then newly elected President of the Academy, Professor Grace Tang. Apart from getting to know more of the College and its Council, she also briefed us on the various tasks for the Academy in the years ahead, namely deeper collaboration with Mainland China, training in private hospitals and manpower planning for doctors and specialists. Since the College has already established close links with our counterparts in the Mainland for many years, the Council decided to support especially the first task. In fact the Academy had a busy schedule of Mainland affairs this year. I represented the College in the delegation to visit Beijing in April. Besides meeting the officials of the Ministry of Health and the various Chinese academies and associations, I also visited the Beijing School of Stomatology and the Chinese Stomatology Association. The Academy was informed by the top officials of the Ministry that China is in the process of establishing a training, accreditation and registration for specialists in Mainland and would value the contribution of the Academy to its development. In August, a delegation of 16 persons visited the Academy to study the Hong Kong system. I led a task force to meet the delegation on behalf of the College and presented to them the training, accreditation and examination formats of the seven dental specialties. It is expected that the dialogue with Beijing would continue.

The College also participated actively to the manpower planning exercise of the Academy. After thorough discussion by the Education Committee and the Council, figures for dental specialists were submitted to the Academy. Further discussion will continue prior to the compilation of a report.

There was a break-through in terms of specialist registration this year. During a special meeting convened by the Secretary for Health, Welfare and Food in January, Dr York Chow informed various representatives of the dental profession that the Bureau intended to amend the Dentists Registration Ordinance by the addition of a Specialist Register. I indicated at the meeting that the College would strongly support this move although the total revamp of the Ordinance should not be delayed for too long. As I understand, subsequently a Bill was submitted to the Legislative Council in July and a Bills Committee has been formed to look at this issue in the coming 2005/2006 legislative session.

As a gesture of long-standing partnership with the Royal College of Surgeons of Edinburgh, together with the two Vice-Presidents and some members of the Council, I attended the opening ceremony and scientific symposium of the Quincentenary Celebration of the College in Edinburgh. A crystal plaque from the College was presented to Professor Jim McDonald,

Dean of the Dental Faculty of the Edinburgh College. As the Closing Ceremony will be held in Hong Kong next year, we will liaise closely with the College of Surgeons of Hong Kong to organise a scientific symposium planned for October 2006.

The College has been the administrator, service provider and accreditator of the CME/CPD programme for practising dentists in the past few years. The Dental Council has decided to re-appoint the College for its new cycle from July 2005 to December 2007. Just to remind you, it is a programme mainly for the non-specialists. As our fellows have to comply with the mandatory CME of the Academy, there is really no need to join this programme. Our fellows are committed to life-long learning. It is praiseworthy that 107 of our fellows use the Membership and Learning Management System (MLMS), which is established by Hong Kong Academy of Medicine to facilitate web learning. This figure represents the highest proportion of fellows among the Academy's Colleges in utilizing the network to enhance their CME/CPD.

As regards the scientific meetings of the year, I regret to say that the spring one had to be cancelled due to difficulty in getting the right speaker. Nevertheless, the autumn meeting was held in September with Dr Lars Salonen from Sweden speaking on the topic of 'Reconstructive Dentistry from a Periodontal View'. This year's Winter Scientific Meeting will be held on 20 November at the Academy with the title 'Evidence-based Clinical Practice'. Professor Malcolm Harris, Professor Fraser McCord and Professor W P Saunders will speak on topics related to Oral & Maxillofacial Surgery, Prosthodontics and Endodontics, which should be of interest to most if not all Fellows and Members.

This year's Fellowship Conferment Ceremony will be held on the 20 November before the Annual Dinner with a total of 17 new Fellows from the various specialties and three Members to be conferred. The Council has also decided to confer the Honorary Fellowship of the College to Professor Malcolm Harris.

The Council has endorsed the establishment of Community Dentistry as a new specialty. Detail of the training pathway is being worked out by the Education Committee before submitting to the Academy for approval. The Council has also decided to present our Past Presidents with a gold pin in recognition of their valuable contributions to the College. Meritorious service medal would be awarded to those out-going Councillors who have served for a long period of time. The other household matters such as office renovation and change of staff were reported in the newsletters.

I would like to extend my deepest appreciation to all members of the Council, specialty boards and various committees for their dedicated and hard work over the past year. Ada and her staff should also be thanked for ensuring the efficient running of the College activities. Finally it is my privilege and honour to serve as President during 2005 and I would like to thank all Fellows and Members for their continuous support.

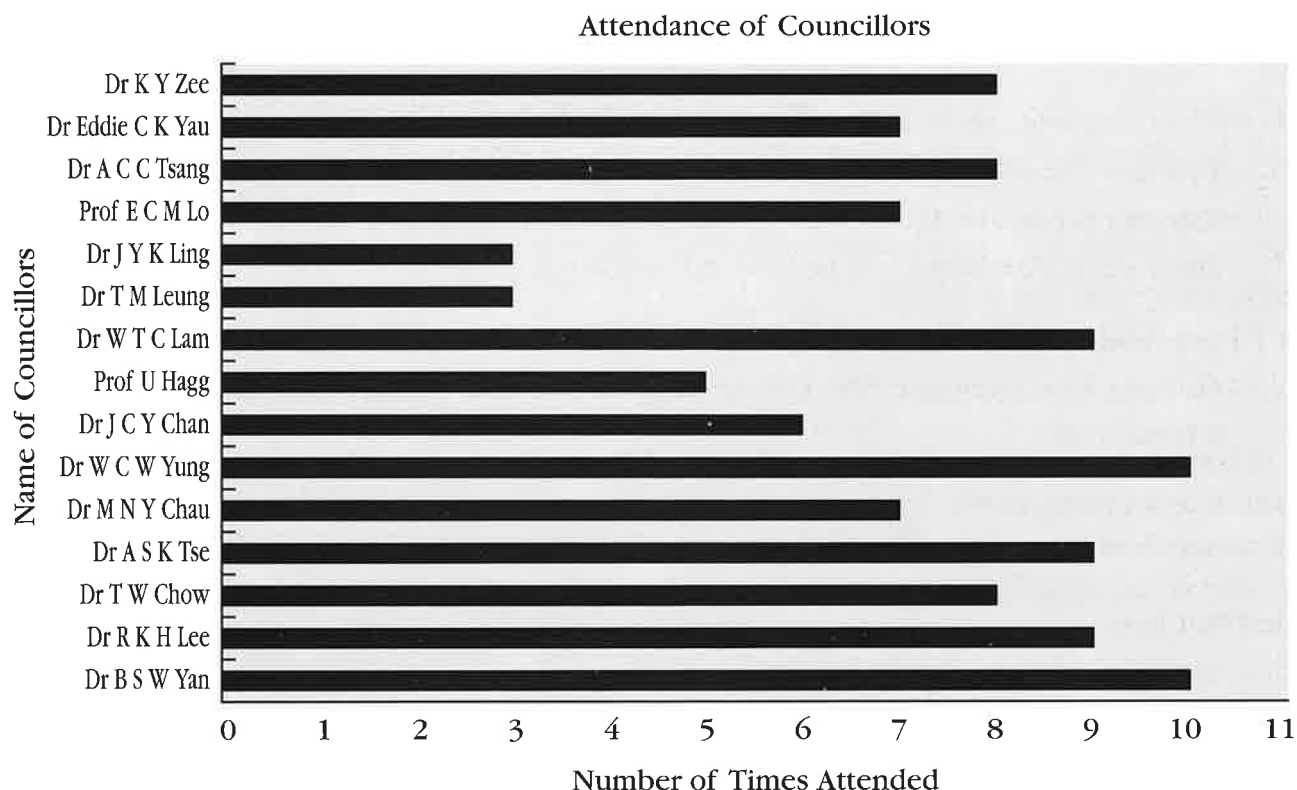

- ✧ The Committee, at the request of the Academy of Medicine to all its fifteen Colleges, participated in manpower planning of specialists.
- ✧ The Committee promoted and advertised conjoint intermediate examinations to attract overseas candidates. Such examinations in year 2006 are scheduled for the month of October when the final event in the Quincentenary period of the Royal College of Surgeons of Edinburgh will be held in Hong Kong.
- ✧ The feasibility and desirability of holding conjoint Exit Examinations with overseas colleges were explored. The College decided that such venture might be best suited for a future date.

2. Meetings

The Specialty Board formally met once in 2004-2005, and has relied heavily on electronic communications in dealing with matters of the Specialty, which proved to be effective. Formal enquiries from various prospective trainees to join the training pathways were discussed.

3. Examinations

A Conjoint MRD RCS/CDSHK intermediate examination was held in November 2004, in which one candidate elected Endodontics as the specialty subject but, unfortunately, was not successful.

An Exit Examination in endodontic specialty was held in November 2004, in which Professor Haapasalo of the University of British Columbia, Canada, attended as a guest examiner. There was one candidate who had successfully passed the examination and admitted as a Specialist in Endodontics.

4. Other activities

The Board worked with the Specialty Board in Periodontology and organized the Winter Scientific Meeting of the CDSHK held in November 2004. The theme is on Periodontal-endodontic inter-relations with Professor Haapasalo, as one of the principal speakers, addressing on topic related to endodontics.

❑ **Training Pathway**

It is the first year that the Family Dentistry pathway is implemented.

❑ **Training**

Seven first-year Family Dentistry trainees began their training in September 2004. Individual trainers were assigned to assist in their training. The structured training included didactic lectures, tutorials, clinic visitations and course work. Four trainees attempted the year-end assessment and three passed. A remedial program was formulated for the unsuccessful candidate. Currently, there are four Family Dentistry trainees attending the Postgraduate Diploma in General Dental Surgery program at the Faculty of Dentistry of University of Hong Kong.

❑ **Course evaluation**

A review to evaluate the first year courses is underway.

❑ **Promotion**

The Specialty Board explored ways of encouraging more dentists for continuing professional development and career advancement. A "multiple entry and multiple exit" system was developed to allow greater flexibility in joining the training pathway by practising dentists who already have some training and relevant qualifications. This new approach was publicized to dental officers in the Government Dental Service and also to dentists in the private sector.

- ✧ At present, the number of Trainers stands at 6, namely Professor A S McMillan, Dr Robin W C Chung, Dr T W Chow, Dr L H Kei, Dr P R H Newsome and Dr John Chai.
- ✧ Dr Kevin H K Yip satisfied the examiners in the Exit Examination and was admitted as a Fellow under the Specialty of Prosthodontics.
- ✧ Dr TSE Chung Ming and Dr CHAN Chi Hong who were Fellows of Dental Surgery were accepted by the Board to become Fellows in Prosthodontics.
- ✧ Currently, there are 19 trainees, 4 trainees are qualified to take intermediate examination and there are no higher trainees in the Specialty.
- ✧ The Conjoint MRD examination is going well into the fourth year. We are trying to recruit more overseas candidates and promote Hong Kong as an Examination Centre for Japan and Australasia. In addition, attempts were made to set up scholarships for Chinese Academics so that they can become our future Fellows.
- ✧ Efforts to inform the lay public of the scopes and realms of the Specialty of Prosthodontics were made by means of articles in local newspapers and radio programmes.
- ✧ Discussions on reciprocal recognition of the FCDSHK (Prosthodontics) and FRACDS (Prosthodontics) of the Royal Australasian College of Dental Surgeons are in progress.

- α The specialty board noted that the Dental Council of Hong Kong is applying dual standards for registration of specialists in Prosthodontics. Hopefully this would be stopped when the new amendment on the Dental Ordinance for specialists registration in place.

Dr Leung Tat Ming, who was an active member of our Subcommittee for the past few years, has resigned from the Subcommittee owing to personal reasons. Despite efforts to retain him in the Subcommittee, we honoured his wish and thanked him once again for his efforts and contribution to the College throughout all these years.

Meanwhile, Dr Wiley Lam has been appointed to, whereas Dr Kenneth Hui has been re-appointed to, the CME Subcommittee to serve a 2-year term commencing April 2005.

2. Secretarial support for the CME Subcommittee:

Our Subcommittee is indeed indebted to both Miss Ada Houn, Manager, and Miss Ling Chow, Secretary, of our College, for their unfailing support and shouldering of all paper and administrative works, with all matters relating to the Academy's, as well as the Dental Council of Hong Kong's, CME/CPD programme. We need to give them our sincere appreciation and gratitude.

3. CME activities ending in December 31, 2004:

There were a total of 12 batches of Fellows whose CME cycles were synchronized to end on December 31, 2004. All but one has met the Academy's CME requirements in maintaining the CME goal. That one particular Fellow, who obtained more than 60 CME points but short of the mandatory 90 marks, was given one year duration to make up his/her shortfalls, while he/she has to start the same new CME cycle concurrently.

4. CME activities for the first eight months of the year 2005:

Up to the end of August, 2005, our CME Subcommittee has vetted, pre-approved, endorsed and accredited a total of 475 scientific meetings, both locally and overseas.

5. Synchronized CME/CPD Cycles commencing January 1, 2005:

Currently we have a total of 197 Fellows. Since January 1, 2005, all these Fellows were grouped under one same batch and started the same CME cycle afresh. Such arrangement greatly improved the administration and recording of the CME scores for each and every Fellow. For the first eight months of the current CME cycle (with cut off date on August 31, 2005), the CME records for our Fellows can be tabulated as follow:

6. Review of the Dental Council of Hong Kong's voluntary Continuing Medical Education Programme for Practising Dentists in Hong Kong

There were a total of 181 registered dentists enrolled for the first cycle of this voluntary programme and our College continued to serve as one of the Administrators of the programme. The CME requirement for each and every enrollee is 15 CME points per year, or a total of 45 CME points per 3-year cycle.

At the end of the first 3-year cycle ending on June 30, 2005, the profile of their CME scores could be tabulated in the following table:

The names of those enrollees who have satisfied the CME requirements have been sent to the Dental Council in early August, 2005. Those who met the requirements should receive a CME Certificate and that they could use the title "CPD-certified (7/2005 - 12/2007)".

A new cycle of Continuing Professional Development Program for Practising Dentists in Hong Kong has commenced since July 1, 2005 but Fellows of HKAM are not required to enroll. Those Fellows who could comply with the HKAM Program are deemed to have complied with the DCHK Program.

7. Handbook on CME/CPD - second edition

The second edition of the Handbook on CME/CPD has been sent to each and every Fellow by post in January 2005. The Principles and Guidelines had been substantially revised and Fellows should be acquainted with its contents. We did receive a few encouraging verbal comments from our Fellows; and we shall continue to try our best to serve our College in general, and our Fellows in particular.

Scientific Meetings Committee

The Scientific Meetings Committee is pleased to report that two scientific meetings had been successfully held in the year 2004 - 2005.

The first one is the 2004 Winter Scientific Meeting held on 21 November 2004 in the Hong Kong Academy of Medicine Building. The main theme of the scientific program was "Periodo-Endo Inter-relations". The overseas invited speakers were Dr Roderick Marshall (Australia) and Professor Markus Haapasalo (Canada). This meeting was attended by 132 participants.

The second one is the 2005 Autumn Scientific Meeting held on September 4, 2005. The title of the scientific programme was "Reconstructive Dentistry from a Periodontal View" and a series of clinically focused lectures was given by Dr Lars Salonen from Sweden in the Hong Kong Academy of Medicine Building. There were 124 registered participants at the lectures.

As the Chairman of the Scientific Meetings Committee, I represent the College of Dental Surgeons as a member of Scientific Programme Committee of the 2006 RCSSED/CSHK Scientific Meeting which marks the conclusion of a year-long celebration of the 500th anniversary of the Royal College of Surgeons of Edinburgh to be held in Hong Kong in October 2006. The first meeting of the Scientific Programme Committee had been held to discuss the general layout of the 3-day programme. More committee meetings will be held to work out the details.

I would like to thank all the members of the Scientific Meetings Committee nominated by the various specialty boards of the College for their contributions. Special thanks go to Miss Ada Houn for her indispensable assistance in organizing the above two scientific meetings.

Treasurer's Report

A modest surplus of HK\$121, 860 was recorded in the Financial Statement for the year ended 31st March 2005. Membership and annual subscription fees remained to be the principle source of revenue. Another major income was derived from the Exit Examinations and Assessments. The scientific meetings recorded a reduced surplus in comparison with the very successful 10th Anniversary Conference in 2003-04. The Council continued to adopt a very conservative policy with respect to our investment and the interest return was nominal.

On the expenditure side, the management fee and salary and allowances were the major operating expenses. The hosting of Conjoint Examinations with the Royal College of Surgeons of Edinburgh annually was the major event of the College and had incurred a small deficit this year. The depreciation had increased resulting from the purchase of additional computer office equipments and minor renovation of the College Chamber. The function expenses had also reduced significantly this year.

The accumulated fund of the College has reached 2.7 million.

NOTES ON THE FINANCIAL STATEMENTS

1. STATUS OF THE COLLEGE

The college was incorporated in Hong Kong on 23rd February, 1993 as a company limited by guarantee. Every member of the college undertakes to contribute, if required, an amount not exceeding HK\$100 to the assets of the college in the event of its being wound up.

The college is engaged in promoting for the public benefit the advancement of knowledge in the field of dental surgery and its associated subjects and promoting training and research in dental surgery.

2. PRINCIPAL ACCOUNTING POLICIES

a) Basis of accounting:

These financial statements have been prepared in accordance with all applicable Hong Kong Financial Reporting Standards (which includes all applicable Statements of Standard Accounting Practice and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants, accounting principles generally accepted in Hong Kong and the requirements of the Hong Kong Companies Ordinance. They have been prepared under historical cost convention.

The Hong Kong Institute of Certified Public Accountants has issued a number of new and revised Hong Kong Financial Reporting Standards and Hong Kong Accounting Standards ("new HKFRSs") which are effective for accounting periods beginning on or after 1st January, 2005.

The College of Dental Surgeons of Hong Kong has not early adopted these new HKFRSs in the financial statements for the year ended 31st December, 2004. The College of Dental Surgeons of Hong Kong has already commenced an assessment of the impact of these new HKFRSs and is not yet in a position to state whether these new HKFRSs would have a significant impact on its results of operations and financial position.

b) Revenue recognition:

Income from subscription and entrance fees is recognised on an accruals basis.

Income from meeting, course and examination is recognised upon completion of services provided.

Interest income is recognised on a time proportion basis.

2. PRINCIPAL ACCOUNTING POLICIES (CONT'D)

c) Depreciation on fixed assets:

Fixed assets are stated at cost less accumulated depreciation and any impairment losses.

Fixed assets are depreciated on the 'straight line method at the following rate:-

College gowns	20% per annum
Leasehold improvement	20% per annum
Furniture and fixtures	20% per annum
Office equipment	20% per annum

d) Inventories:

Inventories are stated at the lower of cost and net realisable value. Cost is calculated by using the weighted average method. Net realisable value is determined by management based on prevailing market conditions.

e) Related parties:

Parties are considered to be related if one party has the ability, directly or indirectly to control the other party, or exercise significant influence over the other party in making financial and operating decisions. Parties are also considered to be related if they are subject to common control or common significant influence. Related parties may be individuals or entities.

f) Cash equivalents:

Cash equivalents represent assets similar in nature to cash, which are not restricted to use.

g) Held-to-maturity securities:

Dated debt securities that the company has the ability and intention to hold to maturity are classified as held-to-maturity securities. Held-to-maturity securities are stated in the balance sheet at amortised cost less any impairment loss. Provision are made when carrying amounts are not expected to be fully recovered and are recognised as an expense in the income and expenditure, such provisions being determined for each investment individually.
