President's Report

It is my great privilege and honour to take up Presidency of the College of Dental Surgeons of Hong Kong from my predecessor Dr Bill Yan since last November. I acknowledge the great support and outstanding help given to me by the serving Council members during my term and all fellows and members in holding up standards of our profession. I also take this opportunity to thank the outgoing Councillors Dr Alex Chan, Dr Michael Chau Dr Wiley Lam and Dr Eddie Yau for their past services. My deepest gratitude also goes to the committee and subcommittee chairmen, members, supervisors, trainers, examiners, assessors and mentors in serving the College voluntarily. Furthermore, I wish to thank on behalf of the College our sister dental faculty of the Royal College of Surgeons of Edinburgh in traveling to Hong Kong to conduct the conjoint examinations with us, the diets has now becoming an important benchmark for various dental specialties in the Asia Pacific region.

We take pride in conforming to continuing education as College fellows, not only to keep up with the current good practice but also to safeguard the oral health of our Hong Kong Community, to give the best possible care and treatment with sound scientific evident based protocols. We will continue to be the administrator and provider for CME/CPD for our fellows, members and the profession. The importance of keeping pace with life-long learning should not be understated.

The new specialty of Community Dentistry was formally endorsed by the College and the Hong Kong Academy of Medicine. We welcome the first fellows in Community Dentistry, in addition to the accreditation of their training pathway, supervisor, trainers, trainees and training centres were endorsed.

In our College development, we will be inducting new members in the field of General Dentistry, a break-through for practicing general practitioners to join the College as an academic home for those who aspire to advanced vocation in Hong Kong. I am confident that this effort will benefit to unite the dental profession as well as to raise the overall standards of dentistry.

A conjoint conferment ceremony will be held with RCSEd on 23 November and the Council decided to confer honorary fellowships to Professor Jonathan Cowpe, Professor William Saunders, Professor Malcolm Jones and Dr Jeffrey Tsang, in recognition of their achievements and contribution in Dentistry.

Our College is privileged to be invited by the Ministry of Health to assist the Mainland in setting up the accreditation of specialist in stomatology. Out of four chosen medical specialties, the Beijing School Stomatology Hospital (BSSH) was chosen to run a pilot scheme in the grand-fathering the first batch of stomatological specialists in oral and maxillofacial surgery and orthodontics. A suggested list of specialists was drawn up which resulted from earlier memorandum signed by the Academy of Medicine and Ministry of Health (MOH) in August 2006 and meetings between us and delegations from MOH and BSSH in July and August 2007 respectively. In early November, Dr Roch Lee and myself confirmed the list after a meeting with senior academicians from BSSH, Deans of major mainland Universities and President of the Chinese Stomatology Association. This is an important milestone for mainland in international connection.

As we look back into fourteen years of the establishment of the College, we must be proud of our existence. We will join hands with the Faculty of Dentistry in the 2007 conjoint congress "Second International Conference on Evidence-Based Advanced Dentistry" and I hope you will support this event. The College Annual General Meeting will be held on 18th November 2007 in the midst of the congress.

I regret that the Spring Scientific Meeting was cancelled. Nevertheless, the Autumn Scientific Meeting in October was a double bill presented by Professor Crispan Scully and Professor Lakshman Samaranayake on the title "Emerging Oral Diseases and Treatments" following that in November, Professor Bjorn Zachrisson from Norway will be giving a one day course "High-quality dentistry – seamless cooperation between orthodontists and dentists" as our featured Winter Scientific meeting.

Finally, I would like to thank the Secretariat under the supervision of Ms Stella Chan, Ms Karen Ma and Gladys Yeung for their unfailing secretarial and clerical support to the Council and fellows.



- ➤ The guidelines for accreditation and training in Community Dentistry were approved by the HKAM Education Committee on 12 September 2006.
- ➤ HKAM guidelines for Conducting Examinations were considered and adopted in November 2006.
- ➤ HKAM guidelines for Certification for Specialist Registration were considered and adopted in December 2006.
- ➤ Assessment of First Fellows in Community Dentistry was conducted on 21 March 2007 with 7 successful candidates admitted as First Fellows.
- Accreditation visits to all training institutions were conducted on 13 September and 18 October 2007.
- > The Committee is working on the continuous assessment of trainees and the College guidelines for Certification for Specialist Registration.

- After the approval of the guidelines for accreditation and training in Community Dentistry by the Hong Kong Academy of Medicine, seven first fellows were admitted into the new speciality in the summer of 2007. The Specialty Board was established by the Council of the College at its meeting on June 25, 2007.
- > Two Specialty Board meetings had been held to consider the applications for becoming a trainee and the arrangements in the approved training centres, and to make arrangements for an exit examination.
- A total of 15 applications for becoming a basic or a higher trainee were received (up to October 17, 2007). One application for higher trainee was accepted. Other applications are being processed.
- ➤ An exit examination was held on September 29, 2007 in which the only candidate had passed all three components of the examination.

> Meetings

The Specialty Board formally met three times in 2006-2007 (till September), in additional to electronic communications needed for dealing with various matters that arose in the interim. A number of items have been discussed.

Certification for Specialist Registration: Guidance notes for Non-Academy Fellow

The Board noted the document from HKAM and welcomed the suggestion that applications for specialist recognition will be referred to the relevant specialty boards, as they are in the best position to look at the accreditation/situation for that specialty.

Application for training centre status for Higher Training

Discussed at a special meeting of the Specialty Board and agreed in principle that the MacLehose Dental Centre (2/F) could be recommended as a training centre (for Higher Training only) subject to submission of some further information. The Board, however, reiterated that it will not allow any short-circuiting of the training pathway, especially on the requirement for a 3-year (or equivalent) full-time, institute-based, academic training in Endodontics.

Eastman Dental Institute as a recognized centre for training

The Board has approved an application for recognition from a HK dentist undergoing training at the Eastman Dental Institute (for a two-year Master degree, 2005-07), which training will be accepted as equivalent to year 2 and 3 of the basic training in the Endodontics specialty.

Application to Higher Training

An application to Higher Training has been received. Due to the unique nature of the application, the issue was discussed over a number of meetings, and recommendation was yet to be made as of September 2007.

> Examinations

An exit examination was held in November 2006, in which Dr Shirley C N Lai has successfully fulfilled all requirements of the Endodontic specialty and was recommended for fellowship to the College and HKAM. Materials submitted for this exit examination (log cases and written essay) were forwarded to Professor Saunders of RCSEd for comments and benchmarking. Positive comments, with a note for "recommended pass", were received. Another exit examination will be held in November 2007; one candidate has applied to sit for this diet.

For the Conjoint Intermediate/MRD Examinations, one candidate has been successful in October 2006 and has progressed into Higher Training. The next diet of examinations will also be held in November 2007, for which there will be one candidate for the Endodontics specialty.

Revision of Training Pathway

The specialty board met many times in the past twelve months and devoted much time and efforts in revising the training pathway with a view to make the training components easily accessible to general practitioners and user friendly. A draft is now ready for submission to the Education Committee of the College for comments and approval.

Training

Seven paid-up trainees are enrolled as trainees. Three trainees who are full-time dental officers of the Hong Kong Government Dental Service successfully completed their Postgraduate Diploma in General Dental Surgery programme at the University of Hong Kong in September 2007. Twenty training modules have been designed by the specialty board and teachers are recruited to conduct training commencing November 2007.

The fifth diet of the Exit Examination in Orthodontics was held in October 2007. Five candidates completed their higher training and passed the Exit Examination and they are recommended for fellowships of our College and the Academy of Medicine. The successful candidates are Dr Flora S V Lam, Dr Teresa C S Ng, Dr Andrew F S Ng, Dr Charlene C L Wu and Dr John Y C Wu.

A Conjoint Membership Examination in Orthodontics with the Royal College of Surgeons of Edinburgh will be held from 19 to 24 November 2007. There will be 8 candidates sitting for the Part I and 22 candidates sitting for the Part II examinations respectively. This will be one of the largest diets in Hong Kong since 1996.

Currently, there are 5 basic trainees registered in the Specialty.

Application for renewal for training institution status for both Basic and Higher Specialist Training in Orthodontics by the Discipline of Orthodontics at Prince Philip Dental Hospital is under consideration. An application of the Government Dental Service for the Central Government Offices and Yaumatei Dental Clinics as a training Institution for Higher Specialist was considered. Accreditation of trainers are also under way.

I would like to thank all the members of the specialty board, local and overseas examiners, supervisors and trainers of the College for their valuable contributions.

Dr K Y Zee, Chairman of the CME Subcommittee of the previous term, has started a new professional career in Australia since winter, 2006. Members of our CME Subcommittee wished him all the best in his new challenge.

Meanwhile, Dr Roch K H Lee has been recommended and reappointed by the College Council to take up the Chairmanship again, and he has kindly accepted to maintain and uphold the integrity and level of service provided by our Subcommittee.

In order to fill up the vacant member post, Dr Bernie N C Tang, a Fellow from the Orthodontic field, has been recruited to join our family. He has kindly accepted the invitation, and his membership in our Subcommittee, which has been approved by the College Council, was effective from April, 2007. His term of office would be a 2-year term, renewable, subject to the approval from the College Council.

The same 2-year terms of office for Drs Wiley T C Lam and Kenneth K K Hui have also been renewed, commencing from April 2007 too.

2. Synchronized CME/CPD Cycle from January 1, 2005 to December 31, 2007:

From the recommendation by the Dental Council of Hong Kong, a few non-Fellow specialists, who have the "specialists" title under the Dentists Registration Ordinance, but not "Fellows" of the Hong Kong Academy of Medicine, have joined the same CME/CPD cycles similar to other ordinary Fellows. On a pro-rata basis, their CME/CPD would also be concluded by December 31, 2007.

A total of 3 Fellows were admitted in November 2006 to the Hong Kong Academy of Medicine. Similarly, they were having the same CME/CPD requirement as other Fellows. Their CME/CPD cycle consisted of only one year commencing January 1, 2007, and their CME/CPD requirement would be 30 points, on the same pro-rata basis.

3. CME/CPD activities for the first 30 months of the current CME/CPD cycle:

Since January 1, 2005 and up to the end of June, 2007, our CME Subcommittee has vetted, pre-approved, endorsed and accredited a total of 1832 scientific meetings, both locally and overseas.

4. Synchronized CME/CPD Cycles commencing January 1, 2005:

Currently we have a total of 193 Fellows in our College needing to fulfil the Academy's CME/CPD requirement. Since January 1, 2005, all these Fellows were grouped under one same batch and started the same CME/CPD cycle afresh. For the first 30 months of the current CME/CPD cycle (with cut off date on September 30, 2007), the CME/CPD records for our Fellows can be tabulated as follow:

May this report also serve as a reminder to those Fellows who, at the current moment, still fall short of the required 90 CME/CPD points. Please take the time and effort to submit all your unclaimed CME/CPD activities, to avoid the last minute rush.

5. CME/CPD requirement for Fellows who are practicing overseas:

After obtaining approval from the College Council, all Fellows who are practicing overseas, and having obtained the Practicing Certificate as a Specialist from their respective local Dental Council, as well as CME/CPD endorsement, will be automatically be regarded as compliance to the HKAM's CME/CPD requirement.

This will save a lot of efforts by these overseas Fellows concerned, with less paper-works and application procedures. Such an arrangement meets no objections so far by these overseas Fellows.

6. Review of the Dental Council of Hong Kong's voluntary Continuing Professional Development (CPD) Programme for Practising Dentists in Hong Kong:

A total of 12 dentists have chosen the College as their CME/CPD administrator. Their CME/CPD cycle will also be concluded by December 31, 2007. Their performance so far, with a cut-off date on September 30, 2007, could be tabulated as follow:

Scientific Meetings Committee

The Scientific Meetings Committee is pleased to report that a RCSEd/CSHK Conjoint Scientific Congress with the theme "Surgery: East Meets West" in which our College was one of the major supporters was successfully held on 11-13 October, 2006. There were over 530 pre-registered participants and many on-site registrants. This congress held in the Hong Kong Academy of Medicine Building marked the conclusion of a year-long celebration of the 500th anniversary of the Royal College of Surgeons of Edinburgh. In this Congress, the College was allocated one day for holding a dental symposium on 11 October. The invited overseas dental speakers included Professor Jonathan Shepherd, Dr Ian Ormiston, Dr Vincent Bissell, and Dr David Birnie. The invited local dental speakers included Professor L K Cheung, Professor Urban Hagg, Dr T K Chow, Dr T W Chow, Dr Frederick Chu, and Dr W M Tsang. There were a number of oral and poster presentations at the congress. Awards were given to the best oral presentations in the field of dentistry and OMFS, one for fellow (winner: Dr. Ricky Wong) and one for trainee (winner: Dr. S.L. Lau).

In 2007, The Faculty of Dentistry of the University of Hong Kong celebrates its silver jubilee. The College will hold a conjoint congress with the Faculty of Dentistry on 17-18 November, 2007 and also sponsor a one-day symposium by Prof. Bjorn Zachrisson on November 19. Two representatives from the College are in the main organizing committee of the conjoint congress and there are College fellows in a number of the subcommittees.

Committee of General Dentistry

It was a fruitful year for the development of General Dentistry in Hong Kong.

The College of Dental Surgeons of Hong Kong (CDSHK) established the Committee of General Dentistry (CGD) on March, 2007.

CGD introduced the Guidelines for Accreditation and Training in General Dentistry, a Qualification Framework on General Dentistry (GDQF) and a new qualification, Membership in General Dentistry (MGD) to the profession in a lecture organized by the HKDA on May, 2007.

The lecture was well attended despite the bad weather. It reflects the keen interest on life long learning from our local colleagues.

The main focus of CGD this year was to admit the first special diet of MGD by Credit Accumulation and Transfer (CAT). CGD widely publicized the MGD by sending out CDs to all dentists in Hong Kong. The College website was also constantly updated to keep our colleagues well informed of the recent development.

The College Council approved a well represented assessment panel with fellows from all Specialties. It was led by our Past President, Dr. Bill Yan, who served as the Chief Assessor. The assessment panel decided on the assessment criteria and logistics.

The assessor panel conducted two rounds of assessment for MGD by CAT - special diet in September and October.

40 MGD applications were approved on 22 October 2007 Council meeting.

With the new blood, we are creating a talent pool to work for the betterment of General Dentistry in Hong Kong. Our future tasks include research on the appropriate competency model for the MGD. It is important for designing the best training curriculum and examination syllabus.

I personally thank the unfailing support from all the councillors and assessors to make this long overdue initiative a reality.

We welcome all new MGD holders to the academic home for dentists.

Treasurer's Report

The College recorded a modest deficit of HK\$30,856 in the Financial Statement for the year ended 31st March 2007. Membership and annual subscription fees remained to be the principle source of revenue. Increased number of candidates in the Exit Examinations in 2006 had resulted in a significant increase of related income. Scientific meetings held by the College had taken an adverse turn and incurred a moderate deficit of HK\$79,156. The Council adopted a conservative policy with respect to our investment and the interest return was nominal.

On the expenditure side, the management fee and salaries and allowances were the major operating expenses. A new manager joined the College in January 2007. There was a 22 % increase in the overall expenditure on salaries and allowances for our staff this year. The hosting of Conjoint Examinations with the Royal College of Surgeons of Edinburgh annually was the major event of the College. The greatest part of the expenditure derived from the traveling and accommodation of examiners from overseas and the CDSHK shared a small deficit of HK\$6,537 in 2006. The function expenses had a significant reduction this year.

The accumulated fund of the College has reached 2.62 million.

On behalf of the College, I would like to convey my sincere gratitude to our Honorary Auditors, Mr. Li Ka Cheung Eric of Messrs Li, Tang, Chen & Co. for his indispensable professional advice and services in the past year. Mr. Li has kindly offered himself for reappointment. Special thanks are due to our College staff for providing excellent secretarial assistance.

NOTES ON THE FINANCIAL STATEMENTS

1. STATUS OF THE COLLEGE

The college was incorporated in Hong Kong on 23rd February, 1993 as a company limited by guarantee. Every member of the college undertakes to contribute, if required, an amount not exceeding HK\$100 to the assets of the college in the event of its being wound up.

The registered office of the college is located at Room 902, HKAM Jockey Club Building, 99 Wong Chuk Hang Road, Aberdeen, Hong Kong.

The college is engaged in promoting for the public benefit the advancement of knowledge in the field of dental surgery and its associated subjects and promoting training and research in dental surgery.

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the periods presented, unless otherwise stated.

a) Basis of preparation:

The financial statements of the college have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") (which also includes Hong Kong Accounting Standards and Interpretations) issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the Hong Kong Companies Ordinance. These financial statements are prepared under the historical cost convention.

The preparation of accounts in conformity with HKFRSs requires management to make judgments, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenditure. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which from the basis of making the judgments about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods

b) Adoption of new/revised HKFRSs:

In current year, the college adopted new/revised standards and interpretation of HKFRS issued by HKICPA which are effective for the accounting period beginning on or after 1st January, 2006. The adoption of these new/revised HKFRs has no material impact on the financial statements.

NOTES ON THE FINANCIAL STATEMENTS

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)

c) Property, plant and equipment:

Property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after the property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the income and expenditure account in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of the property, plant and equipment, the expenditure is capitalised as an additional cost of that asset.

Depreciation on property, plant and equipment is calculated by the straight-line method to allocate cost to their residual value over their estimated useful lives as follows:

College gowns	20% per annum
Leasehold improvement	20% per annum
Furniture and fixtures	20% per annum
Office equipment	20% per annum

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each balance sheet date. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

An item of property, plant and equipment is derecognised upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. The gain or loss arising on derecognition of the asset (calculated as the difference between the net sale proceeds and the carrying amount of the asset is included in the income and expenditure account in the year in which the item is derecognised).

d) Inventories:

Inventories are stated at the lower of cost and net realisable value. Cost is calculated by using the weighted average method. Net realisable value is determined by management based on prevailing market conditions.

e) Impairment:

At each balance sheet date, an assessment is made whether there is any indication of impairment of any asset, or whether there is any indication that an impairment loss previously recognised for an asset in prior years may no longer exist or may have decreased. If any such indication exists, the asset's recoverable amount is estimated. An impairment loss is recognised whenever the carrying amount of an asset or its cash-generating unit exceeds its recoverable amount.

NOTES ON THE FINANCIAL STATEMENTS

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)

e) Impairment: (CONT'D)

A previously recognised impairment loss is reversed only if there has been a change in the estimates used to determine the recoverable amount of an asset, however not to an amount higher than the carrying amount that would have been determined (net of any depreciation), had no impairment loss been recognised for the asset in prior years.

f) Revenue recognition:

Income from subscription and entrance fees is recognised on an accruals basis.

Income from meeting, course and examination is recognised upon completion of services provided.

Interest income, on an accrual basis using the effective interest method by applying the rate that discounts the estimated future cash receipts through the expected life of the financial instrument to the net carrying amount of the financial assets.

g) Related parties:

For the purposes of these financial statements, parties are considered to be related to the college if the college has the ability, directly or indirectly, to control the party or exercise significant influence over the party in making financial and operating decisions, or vice versa, or where the college and the party are subject to common control or common significant influence. Related parties may be individuals (being members of key management personnel, significant councillors and/or their close family members) or other entities and include entities which are under the significant influence of related parties of the college where those parties are individuals and postemployment benefit plans which are for the benefit of employees of the college or of any entity that is a related party of the college.

h) Cash and cash equivalents:

For the purpose of the cash flow statement, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the college's cash management.

i) Retirement benefit costs:

The college operates a defined contribution retirement scheme under the Mandatory Provident Fund Schemes Ordinance (the "MPF Scheme") for those employees of the college.

NOTES ON THE FINANCIAL STATEMENTS

2. SUMMARY OF SIGNIFICANT ACCOUNTING POLICES (CONT'D)

i) Retirement benefit costs: (CONT'D)

The college's contributions to the MPF Scheme are made based on a percentage of the eligible employees' relevant income as defined in the Mandatory Provident Fund Schemes Ordinance. These contributions are expensed as incurred. The assets of the scheme are held separately from those of the college in independently administered funds.

j) Held-to-maturity financial assets:

Debt securities that the college has the positive ability and intention to hold to maturity are classified as held-to-maturity financial assets. Held-to-maturity financial assets are initially recognised in the balance sheet at fair value plus transaction costs. Subsequently, they are stated in the balance sheet at amortised cost less impairment losses.

11. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The main risks arising from the college's financial instruments are credit risk and liquidity risk. The college does not have any written risk management policies and guidelines. However, the council meet periodically to analyse and formulate measures to manage the college's exposure to these risks. Generally, the college introduces conservative strategies on its risk management. As the college's exposure to these risks is kept to a minimum, the college has not used any derivatives and other instruments for hedging purposes. The college does not hold or issue derivative financial instruments for trading purposes. The councillors review and agree policies for managing each of these risks and they are summarised as follows:

a) Credit risk

The maximum exposure to credit risk in the event that the counterparties fail to perform their obligations as at 31st March, 2007 in relation to each class of recognised financial assets is the carrying amount of those assets as stated in the balance sheet. In order to minimise the credit risk, the councillors has established monitoring procedures to ensure that follow-up action is taken to recover the debts. In addition, the college reviews the recoverable amount of each individual account receivable at each balance sheet date to ensure that adequate impairment losses are made for irrecoverable amounts. In this regard, the councillors consider that the college's credit risk is significantly reduced.

The credit risk on liquid funds is limited because the counterparties are banks with sound credit ratings.

b) Liquidity risk

Prudent liquidity risk management implies maintaining sufficient cash. The college aims to maintain flexibility in funding by keeping adequate liquid cash available.

c) Fair value:

The fair values of the following financial assets and financial liabilities are considered to be the same as the carrying amounts because of short term maturity of those financial instruments: cash and bank balances, subscription receivable, interest receivable, prepayments, accrued expenses and receipts in advance.
