This year marks the 15th Anniversary of our College and we are engaged in celebrating the occasion with other medical Colleges of the Hong Kong Academy of Medicine. The College's annual general meeting will be held after the dental session of the Scientific programme and an admission of Honorary Fellows, Fellows and Members will be held in the evening.

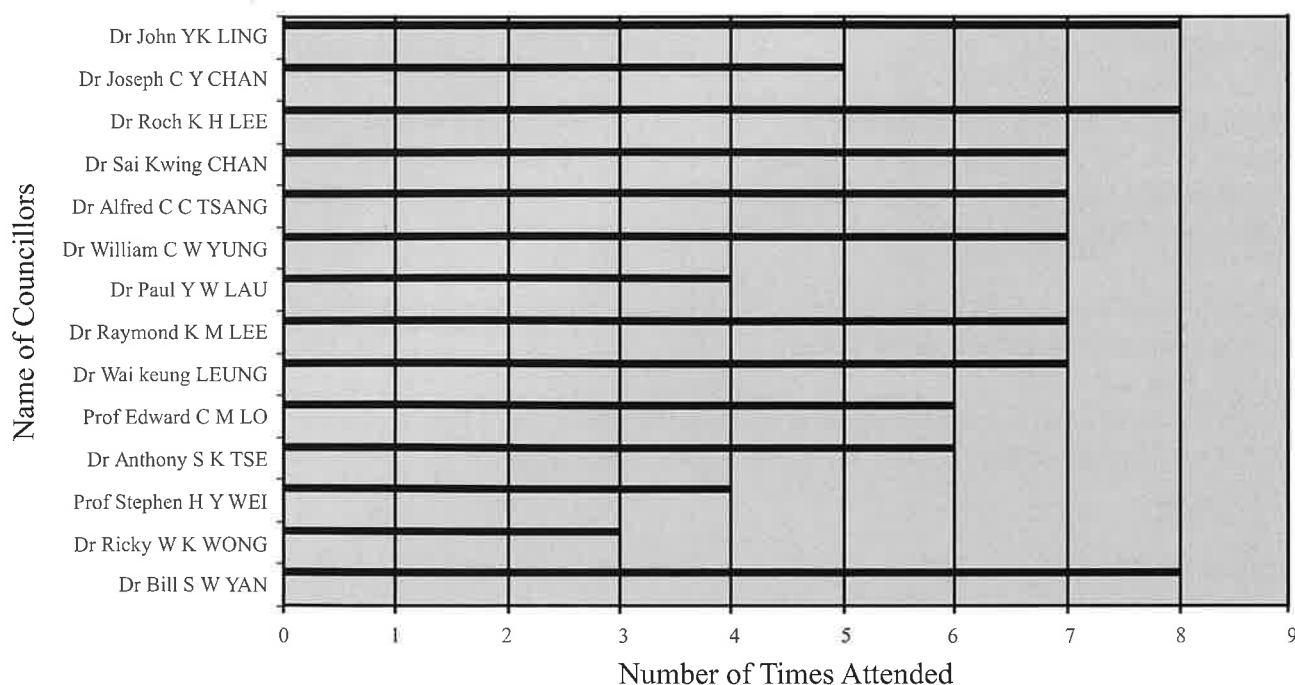

### ➤ Meetings

The Specialty Board has dealt with various matters in 2007-08; some notable items are outlined below.

#### *Acceptance in principle as training centre for Higher Training*

Having received all updated information, the Board has agreed in principle that the MacLehose Dental Centre (2/F) may be accepted as a training centre (for Higher Training only).

#### *Application to Higher Training*

Several applications to Higher Training have been received. After much discussion, three (3) candidates have been admitted in 2008 to begin their Higher Training in the specialty.

### ➤ Examinations

The conjoint Intermediate/MRD Examinations in 2007 had one candidate elected Endodontics as her specialty field, who has attained a passing grade. The next diet of examinations will be held in November 2008, for which two (2) candidates from the Endodontic specialty will be sitting.

An Exit examination was held in November 2007, in which Prof. W.P. Saunders has kindly presided the oral examination. One candidate, Dr. Johnny Y.F. Mak has successfully fulfilled all requirements of the Endodontic specialty and was recommended for fellowship of the College and of HKAM. The next Exit examination will be held in December 2008; one candidate has applied to this exam.

### **Revision of Training Pathway**

The specialty board met numerous times and devoted much time and efforts in revising the training pathway to allow greater collaboration between The College of Dental Surgeons, the Faculty of Dentistry of University of Hong Kong and the Government Dental Service in providing training for this specialty. The revised pathway was commented by the Education Committee with further adjustments and approved by the Education Committee. The revised pathway was then formally submitted to the Council of the College of Dental Surgeons of Hong Kong.

### **Training**

Enrolled trainees are currently receiving training conducted by the Specialty Board. Two trainees who are full-time dental officers of the Hong Kong Government Dental Service are receiving training by specialists in Oral and Maxillofacial Surgery in dental departments of government hospitals.

### **Additional training Centres**

Members of the Specialty Board conducted visitations of Kennedy Town Community Centre Dental Clinic, MacLehose Dental Centre and Cheung Sha Wan Dental Clinic of Government Dental Service, and found them suitable as training centres for the Specialty of Family Dentistry pending formal approval by the Council of The College of Dental Surgeons.

A Conjoint Membership Examination in Orthodontics with the Royal College of Surgeons of Edinburgh was held from in November 2007. Eight candidates sat for the Part I and 22 candidates sitting for the Part II examinations respectively. The 2008 diet for MOrth(Edinburgh) examinations scheduled in November shall only have overseas candidates for both Part I and II.

Since the Dental Faculty of the Royal College of Edinburgh have removed Part I examination from next year onwards, local trainees may take the Part I examination of the Royal Australasian College of Dental Surgeons for their Basic training requirement.

Currently, there is 1 basic trainee and 5 higher trainees registered in the Specialty of Orthodontics.

We approved training institution status for both Basic and Higher Specialist Training in Orthodontics by the Discipline of Orthodontics at Prince Philip Dental Hospital. The Government Dental Service for the Central Government Offices and Yaumatei Dental Clinics were also approved by Council as a training centre for Higher Training.

# Continuing Medical Education Subcommittee

## 1. Composition of the current CME Subcommittee:

Other than the Chairman and an Ex-officio Member, there are four members in the CME Subcommittee and they are serving a staggering two-year-term of office. Currently Drs Wiley Lam and Kenneth Hui are serving their two-year-term commencing from 1 April 2007, whereas Drs. Bernie Tang and Michael Tsang are serving their two-year-term commencing from 1 April 2008.

## 2. HKAM's CME/CPD Cycle from 1 January 2005 to 31 December 2007:

In the last CME/CPD cycle, a total of 201 Fellows had fulfilled the HKAM requirement in obtaining at least 90 CME/CPD points. One Fellow who had been short of CME/CPD points was granted a remedial programme to make up the requirement within 12 months. At the same time this Fellow had to start the new cycle just like the other Fellows

All compliant Fellows were recommended to the Dental Council of Hong Kong for the "CPD-Certified" title.

Fellows who were practicing overseas during the same duration and had complied with their respective local CME/CPD requirement as certified by their respective Dental Council were regarded as having complied with our own CME/CPD requirement. Since they were not practicing in Hong Kong, the "CPD-Certified" title was not applicable to them.

A total of 9 non-Fellow Specialists had also participated in the same CME/CPD programme. Since they had also met the requirement of CME/CPD points on a pro-rata basis from November 2006, they were also recommended to DCHK for the "CPD-Certified" title.

**3. DCHK's voluntary CPD Programme for Practising Dentists in Hong Kong, from 1 July 2005 to 31 December 2007:**

A total of 11 dentists had chosen the College as their Programme Administrator. At the end of the cycle, a total of 10 dentists, who had fulfilled the CPD requirement, were recommended to the DCHK for the "CPD-Certified" title.

**4. HKAM's CME/CPD Cycle commencing on 1 January 2008:**

A total of 3 new Fellows were admitted by HKAM in November 2007, making a total of 205 Fellows undergoing the new CME/CPD cycle (from 1 January 2008 to 31 December 2010). Since 1 January 2008, (with cut off date on 31 August 2008) the CME/CPD records for our Fellows can be tabulated as follow:

**5. Applications for accreditation of CME/CPD activities for the first 8 months of the current CME/CPD cycle:**

Since 1 January 2008 and up to the end of August 2008, the CME Subcommittee had vetted, approved, and accredited a total of 365 scientific meetings held locally or in overseas.

**6. DCHK's voluntary CPD Programme for Practising Dentists in Hong Kong commencing on 1 January 2008:**

A total of 8 dentists had enrolled with our College as their Programme Administrator, and their performance so far could be tabulated as follows:

## Scientific Meetings Committee

The Scientific Meetings Committee is pleased to report that our 2007 Autumn Scientific Meeting was successfully held in the Prince Philip Dental Hospital on October 28 (Sun) with an attendance of over 100. The two speakers, Prof. Crispian Scully from the Eastman Dental Institute in London and Prof. Lakshman Samaranayake from the University of Hong Kong, delivered an educational talk on oral biofilm, oral soft tissue lesions, emerging oral diseases and their management.

In November 17-18, 2007, we had a well-attended conjoint congress with the Faculty of Dentistry, The University of Hong Kong. There were around 500 participants, including 150 from overseas, and over 30 distinguished overseas and local speakers. The presentations in the 2-day programme covered a wide range of topics in all the major specialties and practice of dentistry. In addition, our College helped to organize a post-congress course delivered by Prof. Bjorn Zachrisson from the University of Oslo on "High-quality dentistry - seamless cooperation between orthodontists and dentists".

Our 2008 Spring Scientific Meeting conjoint with the 19th Convocation of the Royal Australasian College of Dental Surgeons was successfully held on May 30 to June 2 in the Hong Kong Convention and Exhibition Centre. There were over 500 participants in this meeting with more than 200 coming from overseas, mainly from Australia and New Zealand. The 3-day scientific programme was very rich, with excellent presentations by 31 invited speakers, 8 local and 23 overseas, covering a wide range of topics in all the major specialties and general practice of dentistry. Besides, there were a number of short oral presentations by the participants and over 15 exhibition booths showing various dental equipment and products. Our College had obtained a grant from the Hong Kong government through the Professional Services Development Assistance Scheme to defray part of the cost of this meeting.

On August 31, 2008 Dr. Robert Wassell and Dr. Amar Naru from the School of Dental Sciences, Newcastle University delivered an informative and enjoyable one-day programme on applied occlusion in our Autumn Scientific Meeting held in the HKAM Jockey Club. Lively animation was used to illustrate the principles of occlusion and occlusal adjustment. Real patient cases were used during the presentation. The participants, around 130 in number, had good discussions with the two expert speakers.

I would like to thank all the members of the Scientific Meetings Committee nominated by the various specialty boards of the College for their contributions. Special thanks go to the secretaries of the College, especially Ms Mimi Cheung, Ms Gladys Yeung and Ms Lilian Cheung, for their indispensable assistance in organizing the above scientific meetings.

Our income had increased substantially owing to the assessment fees and subscriptions of members in the Membership of General Dentistry. The Assessment and Examination fees amounted to \$921,126. Also, there was a surplus of \$ 40,980 for hosting the Conjoint Examinations with the Royal College of Surgeons of Edinburgh.

The management fee, salaries and allowances of the secretariat remained as our main source of expenditure. With the increase in our membership, the administrative team had to be strengthened to cater for the increase in the workload. There was a deficit from running our scientific meetings, which amounted to \$ 20,406. The conducting of scientific meetings was in the past our main source of income. With the plethora of continuing professional education activities run by various organizations locally, it would be plausible that our future scientific meetings would also run into deficit. However, the benefit of the scientific meetings towards our members could not and should not be measured in monetary terms.

The accumulated fund of the College has by now reached over 3.5 million. The council has always been adopting a conservative policy with respect to our investment and has transferred 2 million dollars to Hong Kong Dollar fixed deposit.

On behalf of the College, I would like to convey our sincere gratitude to our Honorary Auditors, Mr. Li Ka Cheung Eric of Messrs. Li, Tang, Chen & Co. for his valuable professional advice and services in the past year. Mr. Li has kindly offered himself for reappointment. Special thanks are also due to our College staff for their excellent secretarial support.

## NOTES ON THE FINANCIAL STATEMENTS

### 1. STATUS OF THE COLLEGE

The college was incorporated in Hong Kong on 23<sup>rd</sup> February, 1993 as a company limited by guarantee. Every member of the college undertakes to contribute, if required, an amount not exceeding HK\$100 to the assets of the college in the event of its being wound up.

The address of the registered office of the college is Room 902, HKAM Jockey Club Building, 99 Wong Chuk Hang Road, Aberdeen, Hong Kong.

The college is engaged in promoting for the public benefit the advancement of knowledge in the field of dental surgery and its associated subjects and promoting training and research in dental surgery.

The financial statements are presented in Hong Kong dollars which is the same as the functional currency of the college.

### 2. BASIS OF PREPARATION

These financial statements have been prepared in accordance with Hong Kong Financial Reporting Standards ("HKFRSs") (which also include Hong Kong Accounting Standards ("HKASs") and Interpretations ("HK - Int") issued by the Hong Kong Institute of Certified Public Accountants ("HKICPA"), accounting principles generally accepted in Hong Kong and the requirements of the Hong Kong Companies Ordinance. They have been prepared under the historical cost convention.

### 3. CHANGES IN ACCOUNTING POLICIES

The HKICPA has issued a number of new and revised HKFRSs and Interpretations that are first effective or available for early adoption for the current accounting year of the college.

There have been no significant changes to the accounting policies applied in these financial statements for the year presented as a result of these developments. However, as a result of the adoption of HKFRS 7, *Financial instruments: Disclosures* and the amendment to HKAS 1, *Presentation of financial statements: Capital disclosures*, there have been some additional disclosures provided as follows:

As a result of the adoption of HKFRS 7, the financial statements include expanded disclosure about the significance of the college's financial instruments and the nature and extent of risks arising from those instruments, compared with the information previously required to be disclosed by HKAS 32, *Financial instruments: Disclosures and presentation*. These disclosures are provided throughout these financial statements, in particular in note 5.

The amendment to HKAS 1 introduces additional disclosure requirements to provide information about the level of capital and the college's objectives, policies and processes for managing capital. These new disclosures are set out in note 14.

Both HKFRS 7 and the amendment to HKAS 1 do not have any material impact on the classification, recognition and measurement of the amounts recognised in the financial instruments.

The college has not applied any new standard or interpretation that is not yet effective for the current accounting period (see note 15).

### 4. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

#### a) Property, plant and equipment:

Property, plant and equipment are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after the property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the income and expenditure account in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of the property, plant and equipment, the expenditure is recognised as an additional cost of that asset.

Depreciation on property, plant and equipment is calculated by the straight-line method to allocate cost to their residual value over their estimated useful lives as follows:

College gowns	20% per annum
Leasehold improvement	20% per annum
Furniture and fixtures	20% per annum
Office equipment	20% per annum

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each balance sheet date. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

An item of property, plant and equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. The gain or loss arising on derecognition of the asset (calculated as the difference between the net sale proceeds and the carrying amount of the asset) is included in the income and expenditure account in the year in which the item is derecognized).

#### b) Inventories:

Inventories are stated at the lower of cost and net realizable value. Cost is calculated by using the weighted average method. Net realizable value is determined by management based on prevailing market conditions.

#### c) Impairment:

At each balance sheet date, an assessment is made whether there is any indication of impairment of any asset, or whether there is any indication that an impairment loss previously recognised for an asset in prior years may no longer exist or may have decreased. If any such indication exists, the asset's recoverable amount is estimated. An impairment loss is recognised whenever the carrying amount of an asset or its cash-generating unit exceeds its recoverable amount.

A previously recognised impairment loss is reversed only if there has been a change in the estimates used to determine the recoverable amount of an asset, however not to an amount higher than the carrying amount that would have been determined (net of any depreciation), had no impairment loss been recognised for the asset in prior years.

**d) Revenue recognition:**

Income from subscription and entrance fees is recognised on an accruals basis.

Income from meeting, course and examination is recognised upon completion of services provided.

Interest income, on an accrual basis using the effective interest method by applying the rate that discounts the estimated future cash receipts through the expected life of the financial instrument to the net carrying amount of the financial assets.

**e) Related parties:**

For the purposes of these financial statements, parties are considered to be related to the college if the college has the ability, directly or indirectly, to control the party or exercise significant influence over the party in making financial and operating decisions, or vice versa, or where the college and the party are subject to common control or common significant influence. Related parties may be individuals (being members of key management personnel, councillors and/or their close family members) or other entities and include entities which are under the significant influence of related parties of the college where those parties are individuals and post-employment benefit plans which are for the benefit of employees of the college or of any entity that is a related party of the college.

**f) Cash and cash equivalents:**

For the purpose of the cash flow statement, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the college's cash management.

**g) Retirement benefit costs:**

The college operates a defined contribution retirement scheme under the Mandatory Provident Fund Schemes Ordinance (the "MPF Scheme") for those employees of the college.

The college's contributions to the MPF Scheme are made based on a percentage of the eligible employees' relevant income as defined in the Mandatory Provident Fund Schemes Ordinance. These contributions are expensed as incurred. The assets of the scheme are held separately from those of the college in independently administered funds.

**h) Held-to-maturity financial assets:**

Debt securities that the college has the positive ability and intention to hold to maturity are classified as held-to-maturity financial assets. Held-to-maturity financial assets are initially recognised in the balance sheet at fair value plus transaction costs. Subsequently, they are stated in the balance sheet at amortised cost less impairment losses.

#### i) Government grants:

Government grants are recognized in the balance sheet initially when there is reasonable assurance that they will be received and that the college will comply with the conditions attaching to them. Grants that compensate the college for expenses incurred are recognized as revenue in profit or loss on a systematic basis in the same periods in which the expenses are incurred. Grants that compensate the college for the cost of an asset are deducted in arriving at the carrying amount of the asset and consequently are recognized in profit or loss over the useful life of the asset.

### 5. FINANCIAL INSTRUMENTS

The college's major financial instruments comprise held-to-maturity financial assets, interest receivable, prepayments, cash and bank balances, accrued expenses and receipts in advance.

The main risks arising from the college's financial instruments are interest rate risk, credit risk, liquidity risk and foreign exchange risk. The college does not have any written risk management policies and guidelines. However, the board of councillors meet periodically to analyze and formulate measures to manage the college's exposure to these risks. Generally, the college introduces conservative strategies on its risk management. As the college's exposure to these risks is kept to a minimum, the college has not used any derivatives and other instruments for hedging purposes. The councillors review and agree policies for managing each of these risks and they are summarized as follows:

#### a) Interest rate risk

The college has interest-bearing bank deposits and no interest-bearing liabilities. The councillors consider that the interest rate risk is not significant.

#### b) Credit risk

As at 31<sup>st</sup> March, 2008, the financial assets of the college that were exposed to credit risk and their maximum exposures were as follows:

c) Liquidity risk

Liquidity risk is the risk that funds will not be available to meet liabilities as they fall due, and it results from amount and maturity mismatches of assets and liabilities.

Prudent liquidity risk management implies maintaining sufficient bank balances.

The following table details the remaining contractual maturities at the balance sheet date of the college's financial liabilities which are based on contractual undiscounted cash flows and the earliest date the college can be required to pay.

d) Foreign exchange risk

The college's financial assets and financial liabilities have their carrying amounts approximately equal to their fair values due to their immediate and short-term maturities.
