President's Report

This is the second year which I have served as the College President. In the past year, there was no change in the College office-bearers but we had Dr. Daniel Fang and Dr. Stanley Lai joining the College Council as new members. I would like to thank all the Office-bearers and Councillors for lending me support and for their great contribution to the success of our College activities reported below.

The Education & Examinations Committee under the chairmanship of Dr Robert NG continued their good work in overseeing the training of trainees and examination arrangements in the eight specialties, as well as the activities of the Committee of General Dentistry. In the past year, our College had conducted Conjoint Intermediate Examinations with the Royal College of Surgeons of Edinburgh in the specialties of Endodontics, Periodontology, Prosthodontics, and Orthodontics. We had also conducted Intermediate Examinations in the specialties of Oral & Maxillofacial Surgery and Family Dentistry with invited external examiners. Exit Examinations were conducted in the specialties of Periodontology, Prosthodontics, and Oral & Maxillofacial Surgery. Five new College Fellows were admitted by the Academy in June this year as FHKAM (Dental Surgery). I would like to congratulate them on their accomplishment. In summer this year our College collaborated with the Royal Australasian College of Dental Surgeons (RACDS) to hold a Conjoint MGD and MRACDS (GDP) Examination with participation from around 40 trainees, and a few MGD trainees chose just to sit for our College Examination.

Our Spring Scientific Meeting this year was held on April 27 in the Prince Philip Dental Hospital with very good attendance. During the meeting, local experts and invited speakers from Singapore delivered excellent talks on the interface between orthodontics and prosthodontics. The Winter Scientific Meeting will be held on 7-8 December 2014 as the first Joint Collegiate Scientific Meeting with the RACDS and the College of Dental Surgeons Singapore (CDSS). The good work of Dr May HO and her committee members in organizing these international scientific meetings is to be applauded.

I am happy to report that nearly all of our College Fellows and Members had fulfilled their requirements for CME/CPD points in the last cycle (2011-13). The new 3-year cycle started on 1 January this year and our CME/CPD Sub-committee under the chairmanship of Dr Sai Kwing CHAN had vetted and approved a number of local CME/CPD providers, and prepared a list of pre-approved overseas dental meetings to facilitate our College members plan their CME/CPD activities. Members are encouraged to read the "Principles & Guidelines on CME/CPD (2014-16)" available from our College website.

Our College has continued to work in close partnership with the Hong Kong Dental Association (HKDA) and earlier this year we signed an MOU with the HKDA for joint publication of the Hong Kong Dental Journal (HKDJ) with its Editorial Board members appointed by both the HKDA and our College. The HKDJ will focus on studies and clinical case reports that are of particular interests to the practising dentists in Hong Kong and the region.

In 26-27 August 2014, I joined the Academy delegation to attend the 48th Malaysia-Singapore Congress of Medicine held in Kuala Lumpur to strengthen the friendship between our counterparts from Singapore and Malaysia. I had met with the presidents from the CDSS and the College of Dental Specialists of Malaysia to share information about our three colleges and to exchange views on how we could enhance our relationships.

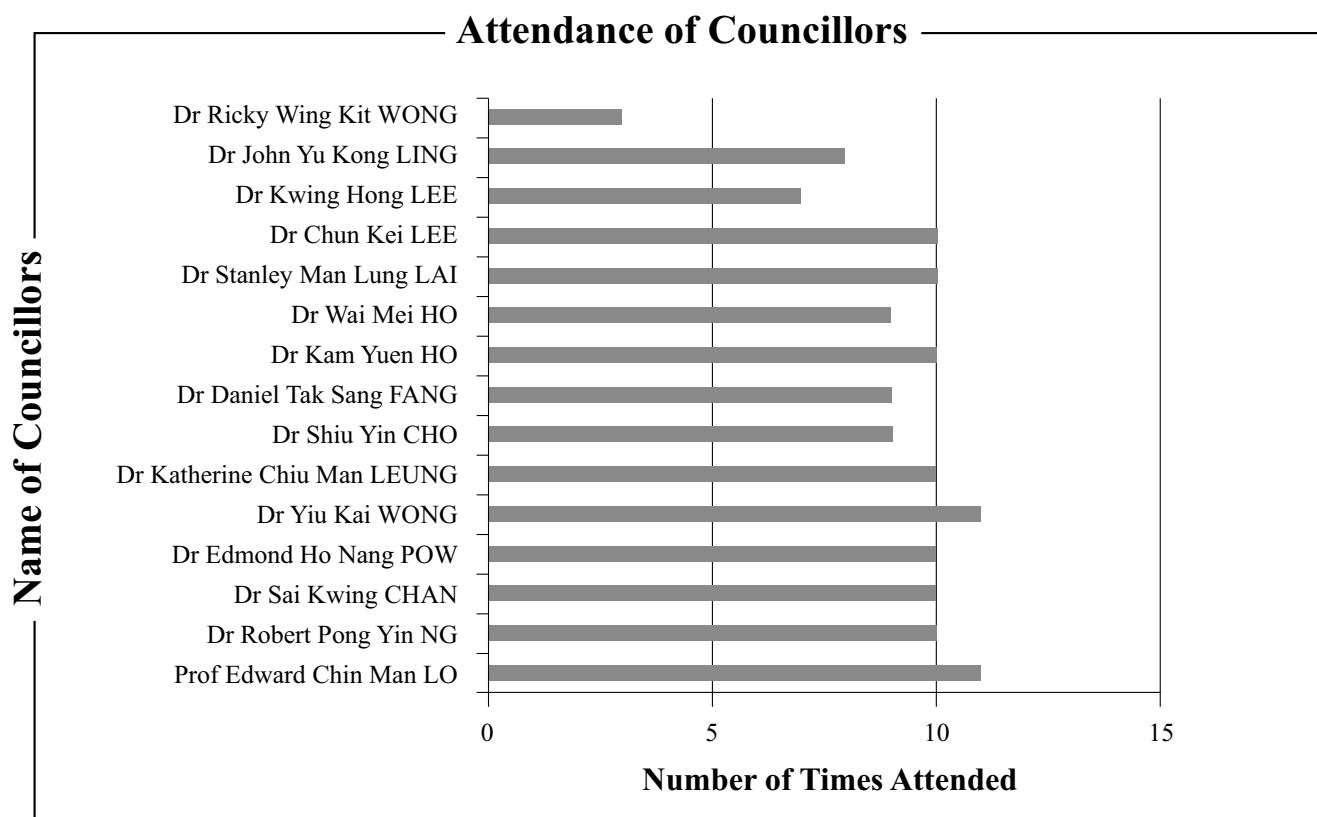

- The Conjoint MOMS(RCSEd), CDSHK(OMS) Intermediate Examination was conducted from 25 to 29 November 2013. There were 4 candidates for the Conjoint MOMS examination and two candidates for the MOMS examination. The examination was helmed by the Chief Examiner Prof Nabil SAMMAN. The examiners from the Edinburgh College were Mr Andrew BALDWIN & Mr John ROWSON. All candidates were unsuccessful.
- The SB OMS mounted its own FCDSHK Intermediate Examination this year. The written paper was held on 8 October 2014 while the clinical and viva examination on 15 October 2014. Dr Eddie C K YAU was the Chief Examiner while Mr Michael HAHN was the external examiner. A total of five candidates enrolled for this diet.
- An Exit examination was held on 19 (written) and 24 March 2014 (clinical and viva). Three higher trainees took part and one passed the examination.
- The next diet of Exit examination will be conducted in March 2015. Prof Nabil SAMMAN will be the Chief Examiner.
- At the close of August 2014, there are a total of 9 higher trainees and ten basic trainees registering with the College. Their training progress will be evaluated in September with the Trainee Evaluation Form as assessed by their supervisors and trainers.

Continuing Medical Education Sub-committee

1. Introduction

It is the objective of the Hong Kong Academy of Medicine to promote the advancement of the art and science of medicine, foster the development of postgraduate medical education and continuing medical education as well as promoting the improvement of health care for Hong Kong citizens. The purpose of Continuing Medical Education and Continuous Professional Development (CME/CPD) is to meet these objectives.

In the pursuit of lifelong learning with a view to protect our own patients, CME is now required not only from fellows, but also from our members and trainees as well. This is indeed part and parcel of our professional practice.

The Principle and Guidelines for the cycle 2014-2016 has been in place for nearly one year now. There is certainly room for improvement and updating, the categorization a of CME activities being an example.

The CME Subcommittee follows the policy that accredited CME activities should be educational with an objective to enhance our competence and improve outcome of patient care. Such CME activities must be based upon the best scientific evidence available and free from any undue or biased commercial influence.

From 1 January 2014 and up to the 31 August 2014, our CME Subcommittee has vetted, approved, and accredited a total of 423 (408 approved / 15 rejected) scientific meetings or training courses held locally and overseas.

The current set of Principle and Guidelines for the cycle 2014-2016 has been in use. Further updating will be the norm for all present date programmes. The CME subcommittee has been collecting view from our members and fellows. These will be closely looked into when we are drafting the new Principles and Guidelines for the cycle 2017-2019.

In the past 12 months, the Membership Committee has altogether vetted 66 cases.

On the recommendation of the Committee, the College had the honour to admit Dr Francis So Wah CHAU as an Honorary Fellow this year. Six higher trainees passed the Exit Examinations of their respective Specialty, and completed their specialist training pathways. They were admitted as Fellows in the Specialties of Oral & Maxillofacial Surgery (1 Fellow) Orthodontics (3 Fellows), Periodontology (1 Fellow) and Prosthodontics (1 Fellow).

Twenty basic trainees, who passed the Intermediate Examinations in their respective specialties, were admitted as Members of the College of Dental Surgeons of Hong Kong (MCDSHKs) and became higher trainees.

Nineteen candidates passed the Membership in General Dentistry examination, together with 20 candidates through credit accumulation and transfer, they were recognized as Members in General Dentistry (MGD).

The College of Dental Surgeons of Hong Kong held 2 Scientific Meetings since the last report.

The Winter Scientific Meeting was held on Sunday, 1 December 2013 at the 2 lecture theatres in the HKAM Jockey Club Building. The theme of the meeting was “Management of Endodontic and Periodontic Infections – Now and the Future”. Professor Andrea Mombelli, Professor and Chair of the Division of Periodontology and Oral Physiopathology, University of Geneva, Switzerland and Dr Anil Kishen, Associate Professor and Head, Discipline of Endodontics, University of Toronto were our invited speakers.

This was the first time that 2 parallel morning sessions were organized in our college scientific meetings. In the morning session, Dr Anil Kishen presented his lecture on “Root Canal Disinfection: An Update and Future Directions” Parts 1 and 2 in the Lim Por Yen Theatre. Simultaneously Professor Andrea Mombelli was presenting his topic on “Antimicrobial Advances in Treating Periodontal Disease” Parts 1 and 2 in the Pao Yue Kong Auditorium. The whole event attracted 297 participants which was the highest number of attendees over the past few years. The general feedback was very good.

The Spring Scientific Meeting was held on Sunday, 27 April 2014 in Lecture Theatre I of the Prince Philip Dental Hospital. The theme of the meeting was “Orthodontics and Restorative Dentistry”. Again, we had a full house of more than 280 participants attending the meeting. Two overseas speakers from Singapore and one local speaker have been invited to discuss this interesting but seldom discussed topic. Dr Ansgar C. Cheng, a Prosthodontist and Dr May Ling Eide, an orthodontist, both with the Specialist Dental Group in Singapore, presented two lectures with the title: “Orthodontic and Prosthodontic Paradigms: Contemporary Clinical Management”. In their presentations, they used a different but interesting approach to explore the fundamental and some less commonly known facts regarding recent orthodontic and prosthodontic treatment modalities. The role of newer material, orthodontics, prosthodontics and surgical principles were also discussed. This new

format involving dual speakers in 1 presentation was not only ground breaking but also aroused much interest from the audience.

The invited local speaker was Dr Frankin T T She. He presented 2 lectures: “Molar Up-righting, Intrusion and More – Biomechanical Considerations” and “Orthodontic Rehabilitation of Periodontally-involved Dentition – A Team Approach” He presented the problems involved in orthodontic treatment of pathologically-migrated teeth due to periodontitis and interdisciplinary treatment planning among different dental specialists in the dental team. A number of clinical cases were shown to illustrate the treatment planning and results. These cases were very interesting not only to the orthodontists but also to other dental disciplines.

I would like to take this opportunity to thank the members of the Scientific Meetings Committee for their support. I am also indebted to Dr Robert P Y NG, Dr Simon K Y HO, Dr Stanley M L Lai and Professor W K LEUNG for their immense help in organization of the Scientific Meetings. Last but not least, I have to express my gratitude to Ms Rose Chow and the College Secretariat for their unfailing support in organizing these meetings.

I would like to report on the preparation and execution of the second diet of examination on Membership in General Dentistry (MGD) by full examination and Credit Accumulation and Transfer (CAT). We also conducted the first Conjoint Examination with the Royal Australasian College of Dental Surgeons (RACDS) under MGD/MRACDS (GDP) in 2014.

MGD/MRACDS Conjoint Part I Examination
(by Full Exam and 2009-2011 diet re-sit candidates)

The MGD Part I Examination was held on 5th January, 2014 (Sunday) at the Prince Philip Dental Hospital and 49 candidates with 22 Examiners and 4 Observers attended the examination.

The passing rate was (84%) 41 candidates were eligible to sit in the MGD Part II Examination.

MGD Part II Examination 2014 (by Credit Accumulation and Transfer
- CAT 1 and CAT 2

The MGD Part II Examination – CAT Diet (Clinic Visitation) was held on 17-19 February 2014 at the candidates' dental practices. There was a total of 22 candidates sitting the said exam (Clinic Visitation) and there was a high ratio of passing rate of 95% (21 candidates).

MGD/MRACDS Conjoint Part I Examination
(by Full Exam, 2009-2011 diet re-sit candidates, CAT re-sit Candidate and re-sit MGD/MRACDS (GDP) Conjoint Viva Exam Candidates)

The MGD Part II Examination (Clinic Visitation) and MGD/MRACDS (GDP) Conjoint Viva Examination were held on 18-22 August 2014 at the candidates' dental practices and 5/F HKAM Jockey Club Building, Aberdeen. 42 candidates (36 current diet and 3 re-sit in clinic visitation and 3 re-sit in Conjoint Viva Exam) were eligible to sit for the examination and half of the candidates passed (21 candidates) in this examination.

Treasurer's Report

The College recorded a surplus of HK\$460,578.00 for the financial year ended 31st March 2014. The accumulated fund of the College has reached HK\$4,297,209.00.

The incomes of the College came mainly from membership subscription fees and examination fees. The management fee, salaries and allowances of all staff and the expenses on scientific meetings were the major expenses of the College.

This year, the amount of surplus has been increased by around HK\$300,000 in comparison with that of last year. This is mainly due to the incomes from the MGD Programme and the decrease in the expenditure of the scientific meetings. The revenue from the MGD Programme is yet to be confirmed next year after completion and auditing.

Two scholarships had been awarded to two higher trainees for their clinical training in the United States and Switzerland. Their experiences were reported in the Autumn 2014 issue of the College's Newsletter.

In order to encourage education and training activities for trainees, fellows, members, or even trainers, the Council has passed a resolution to set up a special fund for the Education and Training development for all specialties and General Dentistry. Each specialty can apply for a maximum amount of HK\$30,000 for Education and Training activities, starting from April 2014 till March 2016. Each specialty board, including the Committee of General Dentistry, can submit relevant proposal(s) and budget(s), through the Education & Examinations Committee, to the Council for approval of the corresponding activities. The Council will review this scheme after the 2-year period.

The Council has resolved to maintain a conservative approach to our investment. The College has no intention of investing in local properties, shares or foreign exchange up to the present.

On behalf of the College, I would like to express our sincere gratitude to our Auditor, Dr Eric Li Ka Cheung of Messrs. Li, Tang, Chen & Co., for his professional advice and dedicated service in the past year. Dr Li has kindly accepted our reappointment in the coming year. Furthermore, I would like to thank Ms Sharon Tam, our Executive Officer, for her professional and meticulous service in accounts handling. Our special thanks also go to Ms Rose Chow, our Senior Executive Officer, who oversees the whole secretariat that provides excellent secretarial support.



NOTES ON THE FINANCIAL STATEMENTS

1. GENERAL INFORMATION

The College of Dental Surgeons of Hong Kong (“the college”) was incorporated in Hong Kong on 23rd February, 1993 as a company limited by guarantee. Every member of the college undertakes to contribute, if required, an amount not exceeding HK\$100 to the assets of the college in the event of its being wound up.

The address of the registered office of the college is Room 902, HKAM Jockey Club Building, 99 Wong Chuk Hang Road, Aberdeen, Hong Kong.

The college is engaged in promoting for the public benefit the advancement of knowledge in the field of dental surgery and its associated subjects and promoting training and research in dental surgery.

The financial statements are presented in Hong Kong dollars which is the same as the functional currency of the college.

2. ADOPTION OF NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS (“HKFRSs”)

The Hong Kong Institute of Certified Public Accountants (“HKICPA”) has issued a number of new HKFRSs and amendments to HKFRSs that are first effective for the current accounting period of the college. The councillors of the college consider that those new HKFRSs and amendments to HKFRSs have no material impact on the financial statements for the current and prior years.

The college has not applied any new standard or amendment that is not yet effective for the current accounting period (see note 13).

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the periods presented, unless otherwise stated.

a) Basis of preparation:

The financial statements have been prepared in accordance with HKFRSs (which also include Hong Kong Accounting Standards and Interpretations) issued by the HKICPA, accounting principles generally accepted in Hong Kong and the Hong Kong Companies Ordinance. The financial statements have been prepared under the historical cost convention.

The preparation of financial statements in conformity with HKFRSs requires management to make judgments, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenditure. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgments about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)

a) Basis of preparation: (cont'd)

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

b) Property, plant and equipment:

Property, plant and equipment, other than construction in progress are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after the property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of comprehensive income in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of the property, plant and equipment, the expenditure is capitalised as an additional cost of that asset.

Depreciation on property, plant and equipment is calculated by the straight-line method to allocate cost to their residual value over their estimated useful lives as follows:

College gowns	20% per annum
Leasehold improvement	20% per annum
Furniture and fixtures	20% per annum
Office equipment	20% per annum

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at each balance sheet date. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

An item of property, plant and equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. The gain or loss arising on derecognition of the asset (calculated as the difference between the net sale proceeds and the carrying amount of the asset) is included in the statement of comprehensive income in the year in which the item is derecognized).

c) Inventories:

Inventories are stated at the lower of cost and net realizable value. Cost is calculated by using the weighted average method. Net realizable value is determined by management based on prevailing market conditions.

d) Impairment:

At each balance sheet date, the college reviews internal and external sources of information to determine whether the carrying amounts of its tangible assets have suffered an impairment loss or impairment loss previously recognised no longer exists or may be reduced. If any such indication exists, the recoverable amount of the asset is estimated, based on the higher on its net selling price and value in use.

If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. Impairment losses are recognised as an expenditure immediately.

A reversal of impairment losses is limited to the carrying amount of the asset that would have been determined had no impairment loss been recognised in prior years. Reversal of impairment losses is recognised as income immediately.

Impairment loss on financial assets which is carried at amortised cost is measured as the difference between the asset's carrying amount the present value of estimated future cash flows discounted at the financial asset's original effective interest rate.

e) Revenue recognition:

Income from subscription and entrance fees is recognised on an accruals basis.

Income from meeting, course and examination is recognised upon completion of services provided.

Interest income is recognised as it accrues using effective interest method.

f) Related parties:

(a) A person, or a close member of that person's family, is related to the college if that person:

- i) has control or joint control over the college;
- ii) has significant influence over the college; or
- iii) is a member of the key management personnel of the college or the college's parent.

(b) An entity is related to the college if any of the following conditions applies:

- i) The entity and the college are members of the same group.
- ii) One entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).

f) Related parties: (cont'd)

(b) An entity is related to the college if any of the following conditions applies: (cont'd)

- iii) Both entities are joint ventures of the same third party.
- iv) One entity is a joint venture of a third entity and the other entity is an associate of the third entity.
- v) The entity is a post-employment benefit plan for the benefit of employees of either the college or an entity related to the college.
- vi) The entity is controlled or jointly controlled by a person identified in (a).
- vii) A person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity).

Close members of the family of a person are those family members who may be expected to influence, or be influenced by, that person in their dealings with the entity.

g) Cash and cash equivalents:

For the purpose of the statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the college's cash management.

h) Retirement benefit costs:

The college joins a defined contribution retirement scheme under the Mandatory Provident Fund Schemes Ordinance (the "MPF Scheme") for those employees of the college.

The college's contributions to the MPF Scheme are made based on a percentage of the eligible employees' relevant income as defined in the Mandatory Provident Fund Schemes Ordinance. These contributions are expensed as incurred. The assets of the scheme are held separately from those of the college in independently administered funds.

i) Government grants:

Government grants are recognized in the balance sheet initially when there is reasonable assurance that they will be received and that the college will comply with the conditions attaching to them. Grants that compensate the college for expenses incurred are recognized as revenue in the statement of comprehensive income on a systematic basis in the same periods in which the expenses are incurred. Grants that compensate the college for the cost of an asset are deducted in arriving at the carrying amount of the asset and consequently are recognized in the statement of comprehensive income over the useful life of the asset.

4. FINANCIAL INSTRUMENTS

4A. CATEGORIES OF FINANCIAL INSTRUMENTS

The carrying amount of financial assets is HK\$5,115,788 (2013: HK\$4,838,896) which is represented by cash and bank balance in the balance sheet.

The carrying amount of financial liabilities at amortised cost is HK\$7,100 (2013: HK\$6,800) which is represented by the accrued expenses in the balance sheet.

4B. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The main risks arising from the college's financial instruments are interest rate risk, credit risk, liquidity risk and foreign exchange risk. The college does not have any written risk management policies and guidelines. However, the board of councillors meet periodically to analyze and formulate measures to manage the college's exposure to these risks. Generally, the college introduces conservative strategies on its risk management. As the college's exposure to these risks is kept to a minimum, the college has not used any derivatives and other instruments for hedging purposes. The councillors review and agree policies for managing each of these risks and they are summarized as follows:

a) Interest rate risk

The college has interest-bearing bank deposits and no interest-bearing liabilities. The councillors consider that the interest rate risk is not significant.

b) Credit risk

The college is exposed to credit risk, which is the risk that a counterparty will be unable to pay amounts in full when due. The company's maximum exposure to credit risk in the event of the counterparties failure to perform their obligations as at 31st March, 2014 in relation to each class of recognised financial assets equal to the carrying amounts of those assets as stated in the balance sheet. The company's credit risk are monitored on an ongoing basis.

The credit risk on liquid funds is limited because the counterparties are banks with high reputation.

c) Liquidity risk

Liquidity risk is the risk that funds will not be available to meet liabilities as they fall due, and it results from amount and maturity mismatches of assets and liabilities.

Prudent liquidity risk management implies maintaining sufficient bank balances.

The following table details the remaining contractual maturities at the balance sheet date of the college's financial liabilities which are based on contractual undiscounted cash flows and the earliest date the college can be required to pay.

e) Fair value estimation

The college's financial assets and financial liabilities have their carrying amounts approximately equal to their fair values due to their immediate and short-term maturities.

The college's objectives when managing capital are:

- To safeguard the college's ability to continue as a going concern.
- To support the college's stability and growth; and
- To provide capital for the purpose of strengthening the college's risk management capability.

The college actively and regularly reviews and manages its capital structure to ensure optimal capital structure, taking into consideration the future capital requirements of the college and capital efficiency, projected operating cash flows and projected capital expenditures.

As in prior years, the college monitors capital by reviewing the level of capital that is at the disposal of the college. Capital comprises accumulated funds.

13. POSSIBLE IMPACT OF AMENDMENTS, NEW STANDARDS AND INTERPRETATIONS ISSUED BUT NOT YET EFFECTIVE FOR THE YEAR ENDED 31ST MARCH, 2014

Up to the date of issue of these financial statements, the HKICPA has issued a number of amendments and new standards which are not yet effective for the year ended 31st March, 2014 and which have not been adopted in these financial statements.

The college is in the process of making an assessment of what the impact of these amendments and new standards is expected to be in the period of initial application. So far it has concluded that the adoption of them is unlikely to have a significant impact on the college's results of operations and financial position.
