## President's Report

The College of Dental Surgeons was founded in 1993. For a professional college, twenty two years probably make us barely in our infancy. Thanks to the dedicated effort of all past and present Council members, backing from our fellows and members, collaborations from our international sister Colleges and support from the Hong Kong Academy of Medicine, our College takes pride to shoulder the entrusted missions for the training of Specialists and General Dentists for the people of Hong Kong.

The College is privileged to have enjoyed another fruitful year. First and foremost, I am much obliged to all members of the Council, members of the Specialty Boards and various committees. Their dedication and efficiency have been clearly proven. The *esprit de corps* to work for our common goals is unsurpassed. To them, I must express my sincere gratitude and admiration.

There are two clear directions of our work: (1) the training of young dental professionals within a prescribed period; and (2) the life-long maintenance of the standard thus required.

Our eight Specialty Boards have been working continuously to monitor various training programmes and in the conducting of examinations. Under the able chairmanship of Dr Robert NG, the Education and Examination Committee had enabled our College to conduct Conjoint Intermediate Examinations with the Royal College of Surgeons of Edinburgh in the specialties of Periodontology, Prosthodontics, and Orthodontics. Exit Examinations were conducted in the specialties of Community Dentistry, Endodontics, Orthodontics, Paediatric Dentistry, Periodontology, Prosthodontics, and Oral & Maxillofacial Surgery. Fifteen new College Fellows were admitted by the Academy this year as FHKAM (Dental Surgery). In collaboration with the Royal Australasian College of Dental Surgeons (RACDS), a programme of Conjoint MGD and MRACDS (GDP) Examination enlisting 52 trainees is on-going and the next examination will be held in early 2017. The Conjoint Part II Examination would be conducted on 4 and 6 March 2016.

We are now in the second year of the CME/CPD 3-year cycle. The CME Subcommittee, chaired by Dr Edmond POW, had been working diligently to facilitate the acquisition of CME/CPD credits for our fellows, members and trainees. The attainment of the CME/CPD requirement is one way of showing the public and our peer that our expertise and standard are being updated. *Passive participation* is now being challenged by the concept of *maintenance of competency* and *credentialling* for the more advanced technology-based proficiency. The next CME/CPD cycle will be in 2017-2019. A new “*Principles & Guidelines on CME/CPD*” would be developed in the coming year.

On 26 April 2015 the College held our Spring Scientific Meeting. The topic was Preventive Dentistry. There were around 260 participants. The Winter Scientific Meeting will be held on 22 November 2015. Dr Stanley LAI and his committee members of our Scientific Committee must be congratulated on these successful events.

On an international level, our collaborations of the Royal College of Surgeons of Edinburgh and the Royal Australasian College of Dental Surgeons continue to move on with mutuality. Apart from the conducting of conjoint examinations, I had attended the RACDS Scientific Meeting held on 17 May 2015. There are in fact a large number of our fellows who are also RACDS fellows.

In 31 July to 2 August 2015, I joined the delegation of the HKAM to attend the 48<sup>th</sup> Malaysia-Singapore Congress of Medicine in Singapore. I had met the presidents of our sister colleges from Singapore and Malaysia and had a good opportunity to share our views. Further strengthening of our professional ties was our common goal. Hopefully we can work on a joint Hong Kong- Singapore-Malaysia scientific congress in 1-2 years.

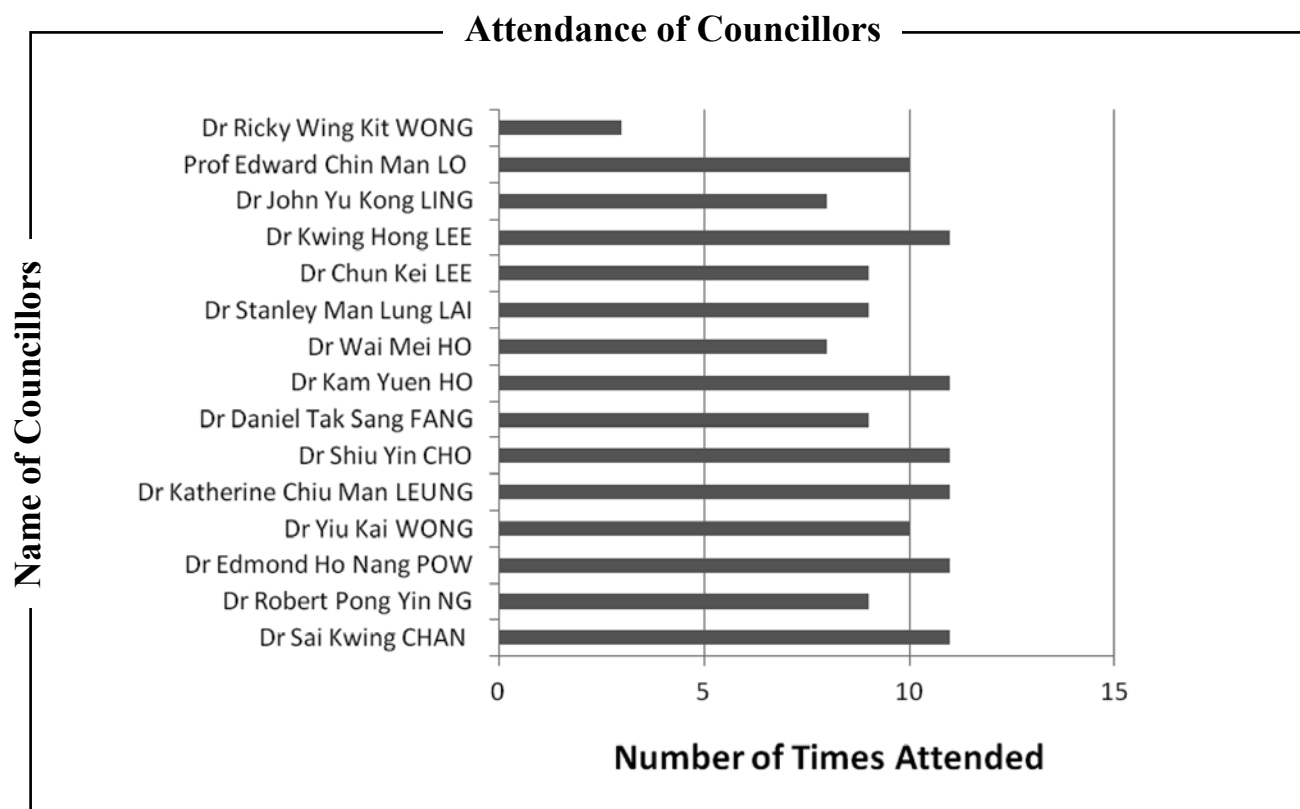

- There are two accredited training centres in Community Dentistry, namely the Faculty of Dentistry of the University of Hong Kong and the Dental Service of the Department of Health of the HKSAR Government. The supervisors of the respective training centre are Prof Edward LO and Dr Wendy CHAM.
- Last year, we had admitted one basic trainee and one higher trainee.
- There are currently 7 basic trainees and 4 higher trainees in Community Dentistry.
- Regular assessments of the trainees were conducted and all trainees had been progressing satisfactorily.
- An MOU was signed in December 2014 between our College and the Royal Australasian College of Dental Surgeons (RACDS) agreeing to hold conjoint MRACDS (Dental Public Health) and Intermediate Examination in Community Dentistry (CDSHK) in the future whenever possible.
- An Exit Examination was held on August 26, 2015 with Prof Micheal MORGAN from Melbourne, Australia as our external examiner. There were two higher trainees sitting for this examination and one of them, Dr Marcus Ho Tak FUNG passed. He will be conferred with the Fellowship of CDSHK in Community Dentistry and the Fellowship of HKAM later this year.

1. At present, there are 8 basic trainees and 9 higher trainees in the pathway. Last year, 1 basic and 2 higher trainees passed the intermediate and exit examination respectively. 4. The Board had played an important role in the set-up and implementation of the new 3-year MDS(Prosthodontics) programme in the Faculty of Dentistry, The University of Hong Kong.
5. The Board had organized a Trainer-Trainee workshop on 3 July 2015 for all trainers and trainees. The workshop was composed of lectures delivered by Dr Annie WAN and Dr Guy CHEUNG followed by a team building exercise which was a ten-pin bowling tournament.

# Continuing Medical Education Sub-committee

## 1. Introduction

It is the objective of the Hong Kong Academy of Medicine to promote the advancement of the art and science of medicine, foster the development of postgraduate medical education and continuing medical education as well as promoting the improvement of health care for Hong Kong citizens. The purpose of Continuing Medical Education and Continuous Professional Development (CME/CPD) is to meet these objectives. In the pursuit of lifelong learning with a view to protect our own patients, CME is now required not only from fellows, but also from our members and trainees as well.

The CME Subcommittee follows the policy that accredited CME activities should be educational with an objective to enhance our competence and improve outcome of patient care. Such CME activities must be based upon the best scientific evidence available and free from any undue or biased commercial influence.

The Principle and Guidelines for the cycle 2014-2016 has been in place for nearly two years now. There is certainly room for improvement. In the next cycle, more close collaborations with the Dental Council of Hong Kong and Hong Kong Dental Association will be fostered.

In the past 12 months, the Membership Committee has altogether vetted 44 cases.

Sixteen higher trainees passed the Exit Examinations of their respective Specialty, and completed their specialist training pathways. ### Joint Collegiate Scientific Meeting 2014

The inaugural Joint Collegiate Scientific Meeting (JCSM) of the three dental colleges, College of Dental Surgeon of Hong Kong (CDSHK), College of Dental Surgeons, Singapore (CDSS) and Royal Australasian College of Dental Surgeons (RACDS) was held on 7<sup>th</sup> – 8<sup>th</sup> December 2014 at the HKAM Jockey Club Building. Around 340 attendees registered for this 2-day meeting. We hope to arouse the profession to give more thoughts to "preventive dentistry" and bring it to their daily practice as it is the key to oral health and dentistry. According to the Oral Health Report by World Dental Federation in 2014, one major strategy to improve oral health in the population is the focus on prevention of oral disease and promotion of oral health. We wish the Hong Kong population can enjoy better oral health, which definitely need the profession to step up and do something. I would like to report on the 2015-2017 MGD Training Programme and the MGD/MRACDS Conjoint Viva Examination (March 2015).

### **2015-2017 Diet - MGD Training Programme (Third Diet)**

A total of 52 MGD Trainee applicants (46 for full examination and 6 for CAT Diet) were approved and endorsed by the College Council meeting in July 2015.

Again, the College of Dental Surgeons of Hong Kong (CDSHK) has appointed the Hong Kong Dental Association (HKDA) as the MGD programme administrator. The first MGD lecture will be kicked off on 20 September 2015.

There are 44 Mentors and 30 Examiners participated in the Programme and their expertise will definitely enhance our programme (please see above list of mentors and examiners). With the large input on the number of Mentors this year, the Mentor-Trainee ratio has substantially been increased from 1 to 4 - 5 candidates to that of 1 to 1 - 2 (for trainees from private sector) and 1 to 2 - 3 candidates (for trainees from the government). This will allow more time and effort for our Mentors to supervise the assigned trainees.

### **2015 MGD/MRACDS Conjoint Part II Examination – By Full Exam (For Re-sit Candidates)**

The MGD Part II Examination (Clinic Visitation) and MGD/MRACDS (GDP) Conjoint Viva Examination was held on 6 and 8 March 2015 respectively. Eighteen candidates were eligible to sit for the examination with 14 candidates passed (78%) and 4 failed (22%). Fourteen colleagues were admitted as MGD and would be conferred in November 2015.

An audit involves performing procedures to obtain audit evidence about the amounts and disclosures in the financial statements. The procedures selected depend on the auditor's judgment, including the assessment of the risks of material misstatement of the financial statements, whether due to fraud or error. In making those risk assessments, the auditor considers internal control relevant to the entity's preparation of the financial statements that give a true and fair value in order to design audit procedures that are appropriate in the circumstances, but not for the purpose of expressing an opinion on the effectiveness of the entity's internal control. An audit also includes evaluating the appropriateness of accounting policies used and the reasonableness of accounting estimates made by the councillors, as well as evaluating the overall presentation of the financial statements.

We believe that the audit evidence we have obtained is sufficient and appropriate to provide a basis for our audit opinion.





### NOTES ON THE FINANCIAL STATEMENTS

#### 1. GENERAL INFORMATION

The College of Dental Surgeons of Hong Kong ("the college") was incorporated in Hong Kong on 23<sup>rd</sup> February, 1993 as a company limited by guarantee. Every member of the college undertakes to contribute, if required, an amount not exceeding HK\$100 to the assets of the college in the event of its being wound up.

The address of the registered office of the college is Room 902, HKAM Jockey Club Building, 99 Wong Chuk Hang Road, Aberdeen, Hong Kong.

The college is engaged in promoting for the public benefit the advancement of knowledge in the field of dental surgery and its associated subjects and promoting training and research in dental surgery.

The financial statements are presented in Hong Kong dollars which is the same as the functional currency of the college.

#### 2. ADOPTION OF NEW AND REVISED HONG KONG FINANCIAL REPORTING STANDARDS ("HKFRSs")

The Hong Kong Institute of Certified Public Accountants ("HKICPA") has issued a number of new HKFRSs and amendments to HKFRSs that are first effective for the current accounting period of the college. The councillors of the college consider that those new HKFRSs and amendments to HKFRSs have no material impact on the financial statements for the current and prior years.

The college has not applied any new standard or amendment that is not yet effective for the current accounting period (see note 13).

#### 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES

The principal accounting policies applied in the preparation of these financial statements are set out below. These policies have been consistently applied to all the periods presented, unless otherwise stated.

##### a) Basis of preparation:

The financial statements have been prepared in accordance with HKFRSs (which also include Hong Kong Accounting Standards ("HKASs") and Interpretations) issued by the HKICPA, accounting principles generally accepted in Hong Kong and the Hong Kong Companies Ordinance. The financial statements have been prepared under the historical cost convention.

The preparation of financial statements in conformity with HKFRSs requires management to make judgments, estimates and assumptions that affect the application of policies and reported amounts of assets, liabilities, income and expenditure. The estimates and associated assumptions are based on historical experience and various other factors that are believed to be reasonable under the circumstances, the results of which form the basis of making the judgments about carrying values of assets and liabilities that are not readily apparent from other sources. Actual results may differ from these estimates.

#### 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)

a) Basis of preparation: (cont'd)

The estimates and underlying assumptions are reviewed on an ongoing basis. Revisions to accounting estimates are recognised in the period in which the estimate is revised if the revision affects only that period, or in the period of the revision and future periods if the revision affects both current and future periods.

b) Property, plant and equipment:

Property, plant and equipment, other than construction in progress are stated at cost less accumulated depreciation and accumulated impairment losses. The cost of an asset comprises its purchase price and any directly attributable costs of bringing the asset to its working condition and location for its intended use. Expenditure incurred after the property, plant and equipment have been put into operation, such as repairs and maintenance, is normally charged to the statement of comprehensive income in the period in which it is incurred. In situations where it can be clearly demonstrated that the expenditure has resulted in an increase in the future economic benefits expected to be obtained from the use of the property, plant and equipment, the expenditure is capitalised as an additional cost of that asset.

Depreciation on property, plant and equipment is calculated by the straight-line method to allocate cost to their residual value over their estimated useful lives as follows:

College gowns	20% per annum
Leasehold improvement	20% per annum
Furniture and fixtures	20% per annum
Office equipment	20% per annum

The assets' residual values and useful lives are reviewed, and adjusted if appropriate, at the end of each reporting period. An asset's carrying amount is written down immediately to its recoverable amount if the asset's carrying amount is greater than its estimated recoverable amount.

An item of property, plant and equipment is derecognized upon disposal or when no future economic benefits are expected to arise from the continued use of the asset. The gain or loss arising on derecognition of the asset (calculated as the difference between the net sale proceeds and the carrying amount of the asset is included in the statement of comprehensive income in the year in which the item is derecognized).

c) Inventories:

Inventories are stated at the lower of cost and net realizable value. Cost is calculated by using the weighted average method. Net realizable value is determined by management based on prevailing market conditions.

#### 3. SUMMARY OF SIGNIFICANT ACCOUNTING POLICIES (CONT'D)

d) Impairment:

At the end of each reporting period, the college reviews internal and external sources of information to determine whether the carrying amounts of its tangible assets have suffered an impairment loss or impairment loss previously recognised no longer exists or may be reduced. If any such indication exists, the recoverable amount of the asset is estimated, based on the higher on its net selling price and value in use.

If the recoverable amount of an asset is estimated to be less than its carrying amount, the carrying amount of the asset is reduced to its recoverable amount. Impairment losses are recognised as an expenditure immediately.

A reversal of impairment losses is limited to the carrying amount of the asset that would have been determined had no impairment loss been recognised in prior years. Reversal of impairment losses is recognised as income immediately.

Impairment loss on financial assets which is carried at amortised cost is measured as the difference between the asset's carrying amount the present value of estimated future cash flows discounted at the financial asset's original effective interest rate.

e) Revenue recognition:

Income from subscription and entrance fees is recognised on an accruals basis.

Income from meeting, course and examination is recognised upon completion of services provided.

Interest income is recognised as it accrues using effective interest method.

f) Related parties:

a) A person, or a close member of that person's family, is related to the college if that person:

- i) has control or joint control over the college;
- ii) has significant influence over the college; or
- iii) is a member of the key management personnel of the college or the college's parent.

f) Related parties: (cont'd)

b) An entity is related to the college if any of the following conditions applies:

- i) The entity and the college are members of the same group.
- ii) One entity is an associate or joint venture of the other entity (or an associate or joint venture of a member of a group of which the other entity is a member).
- iii) Both entities are joint ventures of the same third party.
- iv) One entity is a joint venture of a third entity and the other entity is an associate of the third entity.
- v) The entity is a post-employment benefit plan for the benefit of employees of either the college or an entity related to the college.
- vi) The entity is controlled or jointly controlled by a person identified in (a).
- vii) A person identified in (a)(i) has significant influence over the entity or is a member of the key management personnel of the entity (or of a parent of the entity).

Close members of the family of a person are those family members who may be expected to influence, or be influenced by, that person in their dealings with the entity.

g) Cash and cash equivalents:

For the purpose of the statement of cash flows, cash and cash equivalents comprise cash on hand and demand deposits, and short term highly liquid investments which are readily convertible into known amounts of cash and which are subject to an insignificant risk of changes in value, and have a short maturity of generally within three months when acquired, less bank overdrafts which are repayable on demand and form an integral part of the college's cash management.

h) Retirement benefit costs:

The college joins a defined contribution retirement scheme under the Mandatory Provident Fund Schemes Ordinance (the "MPF Scheme") for those employees of the college.

The college's contributions to the MPF Scheme are made based on a percentage of the eligible employees' relevant income as defined in the Mandatory Provident Fund Schemes Ordinance. These contributions are expensed as incurred. The assets of the scheme are held separately from those of the college in independently administered funds.

##### i) Government grants:

Government grants are recognized in the statement of financial position initially when there is reasonable assurance that they will be received and that the college will comply with the conditions attaching to them. Grants that compensate the college for expenses incurred are recognized as revenue in the statement of comprehensive income on a systematic basis in the same periods in which the expenses are incurred. Grants that compensate the college for the cost of an asset are deducted in arriving at the carrying amount of the asset and consequently are recognized in the statement of comprehensive income over the useful life of the asset.

#### 4. FINANCIAL INSTRUMENTS

##### 4A. CATEGORIES OF FINANCIAL INSTRUMENTS

The carrying amount of financial assets is HK\$6,200,738 (2014: HK\$5,115,788) which is represented by cash and bank balance in the statement of financial position.

The carrying amount of financial liabilities at amortised cost is HK\$374,515 (2014: HK\$7,100) which is represented by the accrued expenses and other payable in the statement of financial position.

##### 4B. FINANCIAL RISK MANAGEMENT OBJECTIVES AND POLICIES

The main risks arising from the college's financial instruments are interest rate risk, credit risk, liquidity risk and foreign exchange risk. The college does not have any written risk management policies and guidelines. However, the board of councillors meet periodically to analyze and formulate measures to manage the college's exposure to these risks. Generally, the college introduces conservative strategies on its risk management. As the college's exposure to these risks is kept to a minimum, the college has not used any derivatives and other instruments for hedging purposes. The councillors review and agree policies for managing each of these risks and they are summarized as follows:

##### a) Interest rate risk

The college has interest-bearing bank deposits and no interest-bearing liabilities. The councillors consider that the interest rate risk is not significant.

##### b) Credit risk

The college is exposed to credit risk, which is the risk that a counterparty will be unable to pay amounts in full when due. The college's maximum exposure to credit risk in the event of the counterparties failure to perform their obligations as at 31<sup>st</sup> March, 2015 in relation to each class of recognised financial assets equal to the carrying amounts of those assets as stated in the statement of financial position statement of financial position. The college's credit risk are monitored on an ongoing basis.

The credit risk on liquid funds is limited because the counterparties are banks with high reputation.

###### c) Liquidity risk

Liquidity risk is the risk that funds will not be available to meet liabilities as they fall due, and it results from amount and maturity mismatches of assets and liabilities.

Prudent liquidity risk management implies maintaining sufficient bank balances.

The following table details the remaining contractual maturities at the end of the reporting period of the college's financial liabilities which are based on contractual undiscounted cash flows and the earliest date the college can be required to pay.

###### d) Foreign exchange risk

###### e) Fair value estimation

The college's financial assets and financial liabilities have their carrying amounts approximately equal to their fair values due to their immediate and short-term maturities.
