Subsequent to the successful completion of the Membership in General Dentistry (MGD) training program 2009-2011, The College of Dental Surgeons of Hong Kong (CDSHK) and Hong Kong Dental Association (HKDA) came to an agreement in May 2012 for HKDA to be the administrator of the MGD training program 2012-2014.

The training program is designed to prepare the MGD trainees for the MGD Part I and Part II examinations. It is a competence-based program according to the guidelines of accreditation and training in MGD. For further details, please refer to CDSHK's website ([www.cdshk.org](http://www.cdshk.org)).

The training program is module-based, consisting of CGD (Committee of General Dentistry) accredited lectures and workshops on clinical practice and essentials of dental practice on General Dentistry. There are some supporting programs to guide trainees in examination preparation.

Selected MGD modules are made available for dental colleagues, who are not MGD trainees, to enroll. The registration fee for each module is HK\$1,500. Please find enclosed the enrollment form for the modules scheduled for the second half of 2012.

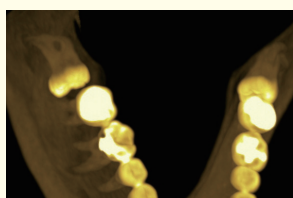

Synopsis : Oral surgical procedures are not usually welcomed by most of our patients. Any hic-cups during the procedure or complications after the surgery will lead to great patient dissatisfaction. Therefore mastering the basic skills in handling common surgical procedures is very important in our daily practice. Knowing when to refer is also vital in the overall risk management.

The lecture will cover the following areas:

1. Basic surgical principles and surgical anatomy
2. Common dentoalveolar surgeries
3. Management of odontogenic infection
4. Management of intra-operative and post-operative surgical complications
5. Management of orofacial pain and temporomandibular disorders
6. Recognition of complex conditions requiring surgical intervention or timely referral

The lecture will be clinically oriented. Practical tips and common pitfalls will be shared and illustrated with different clinical cases.

## Dental Imaging

Dr Thomas Li was a BDS graduate of the University of Hong Kong in 1986. He started his radiology training in the next year and obtained his Diploma of Dental Radiology from The Royal College of Radiologist (UK) in 1993 and his MSc (Dental Radiology) in 1994 under the supervision of late Professor NJD Smith of King's College, University of London. He is the only dentist in Hong Kong being accredited by The Royal College of Radiologists (UK) for his specialist training in radiology.

In 1994, Dr Li was a committee member of the original DGDP(UK) study group leading to the first overseas diet of DGDP(UK) examination in Hong Kong. He was responsible for the training programme.

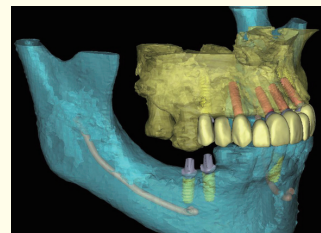
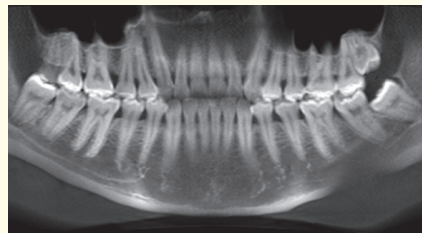
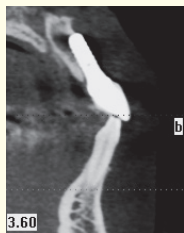
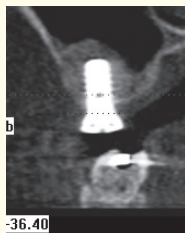
From 1993 to 2008, apart from being a fractional academic staff member, Dr Li also ran a private dental x-ray service and general practice clinic. He is now in full-time private practice.

Dr Li lectures and publishes widely, both locally and internationally. This year he is a speaker of FDI's CE programme for the Asian-Pacific region. He has recently published two chapters in two textbooks and several articles in peer-reviewed journals.

- Synopsis** : Dental imaging is listed as a major competence in the MGD programme. The use of radiographic images is an essential diagnostic tool in dental practice. Diagnostic imaging is a rapidly advancing specialty. For the past twenty years, many forms of dental imaging techniques have been introduced. Common examples include panoramic radiography (OPG), digital imaging systems, computed tomography (CT) and Cone Beam CT. Many general dental practitioners and dental specialists installed their own dental imaging machines which were expensive and needed special training. Those knowledges were often not covered in basic dental training.

Dr Li will cover all areas of radiology as listed in the MGD competences and give an account of Hong Kong dental professionals in the utilization of the latest dental imaging techniques. The full potential of the applications of the technology has yet to be fully explored.

It is important to point out that installing any new dental imaging machine is not just equipping the practice with an extra instrument. It is a completely new approach in patient care. A dentist has to be properly trained to maximize the benefit of any new diagnostic tool.

He is Assistant Dean in Research & Innovation, Assistant Director of Centralized Research Laboratory and Chairman of the Faculty Admission Committee. He is also Guest (Visiting) Professor of Anhui Medical University and Kunming Medical University in China and Honorary Secretary of South East Asian Association of Dental Education.

Dr Chu was conferred Bachelor of Dental Surgery, Master of Dental Surgery and Doctor of Philosophy by the University of Hong Kong. He also obtained a Post-graduate Diploma in Dental Surgery. Dr Chu is a Fellow in both General Dentistry and Dental Public Health of the Royal Australasian College of Dental Surgeons, Fellow in Dental Surgery of the Royal College of Surgeons of Edinburgh, Master of the Academy of General Dentistry and Diplomate of the American Board of General Dentistry. 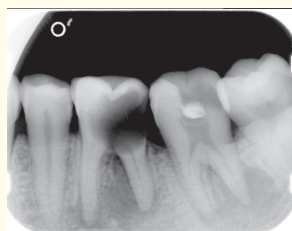

2. Perform special test and clinical diagnostic skill to detect and assess dental caries;
3. Identify the risk factors of a patient suffering from dental caries;
4. Decide the best choice of treatment modality to control, prevent and restore;
5. Motivate and modify patient habit to prevent caries.

Synopsis : This module will introduce MGD trainees to the examination of paediatric patients from infancy through adolescence. It will include the techniques of examination, diagnosis and treatment planning. The contents will cover commonly seen oral conditions and their clinical management including commonly encountered trauma to the dentition and the soft tissues. The treatment of dental caries with the latest restorative materials and techniques will be described. In addition, the management of teeth with pulpal involvement by using indirect pulp capping, pulpotomy and pulpectomy techniques will be shown. MGD trainees are also expected to recognize the development of malocclusion and early interception with guided occlusion techniques including serial extractions will be described.

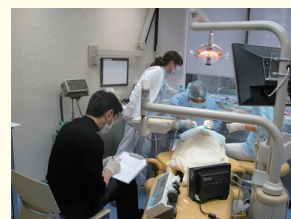
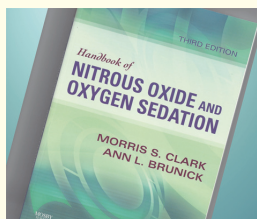

Synopsis : This course will demonstrate different approaches to recognize and manage the anxious, nervous and phobic paediatric patients and their parents in the dental office. Dentists should be able to provide appropriate behaviour modification techniques to allay the fear and anxiety of their patients. The ability to administer "painless" local anesthetic solutions using the proper techniques should be a pre-requisite to all other forms of needed treatment. Dentists should be familiar with the use of various medicaments to allay fear and anxiety using rectal, oral, inhalational and IV routes of administration of medicaments for the patient. Dentists should be competent in the use of nitrous oxide including the proper equipment and concentration of oxygen and nitrous oxide. A dentist must be knowledgeable of the Guidelines for Sedation for Paediatric Patients. When deep sedation is used, the dental team must be fully trained in the administration of the IV method including resuscitation and life support procedures. Cooperation with an anesthesiologist fully trained in the Monitored Anesthetic Care (MAC) techniques is a pre-requisite for deep sedation cases.
